Sir,

I SI (UB) Malay Bhusan Chanda of Permitanki Traffic  
Guard, SPE beg to lodge a written Complaint that on  
19.08.23 at around 12.05 hrs. While on duty at Kachari  
Road, Hospital more area found one TOTO without any  
Registration Number Stationed near Hospital More Kachari  
Road in such a way blocking the free flow of Traffic and  
causing hindrance and danger to the general public and  
other vehicles.

Accordingly I detained said TOTO and on being  
asked the driver disclosed his identity as Pankaj Sarwar  
(25 yrs.) (Contact no, 8101395375) S/O. Neipen Sarwar of  
near Ghogomali High School, Ghogomali, P.S. Bhakli Nagar,  
Dist. Jalpaiguri. Further on being asked to produce relevant  
documents in support of their claim of plying TOTO on  
major road. They/He failed to produce the same. Thereafter  
I seized the said TOTO and detained it and arrested  
the said person under Section 41 Cr. PC in c/w the  
Case after observing all rules and formalities.

Therefore, I would request you to kindly start  
a specific case against the above noted person (TOTO  
Driver) under proper section of law from your end.
