want to state that today morning (19.8.2023), in stead of
reported phone calls, I could not contact my mother,

Received on 19.8.23 at 16:25 hrs. vide Siliguri P.S. GDE no. 779, date- 19.8.23 and started Siliguri P.S. case no. 676/23, date- 19.8.2023, u/s 302/380 IPC, SI Diptajit Dhan has been endorsed for investigation.
Mrs. Sonna Sarkar (Wife) late Narayan Sarkar R/O - Arabinda Pally. (Jyotirajaya apartment) Pabitra Sonomy, Siliguri, then I contacted her neighbor, Mrs Rumpi Bhawal, whom I know to my mother's flat on recent and found her flat locked from outside. Then she went inside and found my mother unresponsive, then I reached to her flat and found her lying abnormally on her bed, not responding to any calls or stimulus, with abnormal injury mark on her face & neck, I also found missing her gold chain on her neck, few gold & Jewellery and cash around A.S. Lax, hence I request you to kindly look into this matter and enquire about this unnatural and suspicious death of my mother and found the guilty as soon as possible.
I think some unknown person murdered my mother
