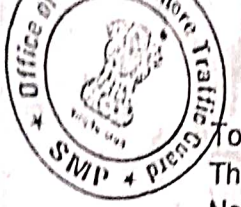

Sir,

In producing herewith 01(One) arrested person namely Bappa Roy, S/O- Pradip Roy of Vill-Naukaghat near Mani Bekary, PO+PS- New Jalpaiguri, Dist- Jalpaiguri (Paddler of Toto (E-rickshaw), without number plate, Red Colour) along with his Toto under seizer, I SI Bipul Barman of Jalpaimore Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 19.08.2023 I along with ASI Dhiraj Chhetri, C-870 Babu Oraon and CV-108 Prangopal Bhowmick while performing traffic regulation duty at AH-2, near Naukaghat More, PS- NJP, Dist- Jalpaiguri found that, the above noted person was plying his Toto (E-rickshaw), as noted above on AH-2 by violating Govt. Order vide Notification number 1526/1(1)-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.

Accordingly, I along with force apprehended him and on asking he could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking he stated his name and address as noted above.

Finding no any alternative way I arrested him u/s 41 Cr. P.C and seized his Toto form his possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought him to Pradhan Nagar Police Station for custody.

I, therefore pray before your kindness that, kindly lodge a specific case in proper section of law against him for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
