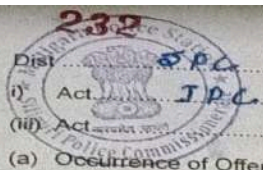

I, Shabin Bano Khan, D/o-Banakaultha

resident of Bankimnagar, Bottle Company bazar, Post + P.S - Bhaktinagar, Dist Jalpaiguri, beg to inform you that today 20/08/23 at about 12.05 I along with my friend Kares came to Aasiana Dhaba for dinner and after reaching there one of friend of Kares namely md Irshad, S/o - md. Sagin of Grandhinagar also came there and after dinner we all were talking normally with each other and suddenly said Irshad became angry and started to assault me and I tried to stop him but said Irshad hit in my head with a stone with a motive to kill me and I receive injury in my head with heavy bleeding and after that being alone I treated at NBMC Hospital with assistance of Police.

After this incident I am passing my every moment with great fears and anxiety as his friends are still continuously threatening me with dire consequences.

It is therefore prayed and you are requested to enquire into the matter and punish said Irshad as Law of the land for ends of justice.
