In producing herewith one accused person namely Sukdev Tarafdar (23 years) s/o- Late Bimal Tarafdar of Vivekananda nagar, near masjid, ward no-42, P.S- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 09(Nine) bottles of 'PRAKASH 60 UP' country spirit each bottle containing 600 ML
2. 08 (Eight) bottles of 'HIMALAYAN GOLD 60UP' country spirit each bottle containing 600 ML


With due respect and humble submission, I PSI Chiranjit Saha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above noted seized articles to the effect that on 19.08.23 at 18.35hrs while performing PS mobile van duty received a source information that one person namely Sukdev Tarafdar was selling liquor in his house situated at Vivekananda nagar, near masjid under Bhaktinagar PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 967 dated 19.08.23. As per your kind instruction myself along with ASI Chandra Prakash Adhikary, C/374 Debraj Biswas proceeded to the PO to work out the information. At 18.55 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid at the house of the above accused person and was able to detain one person who disclosed his identity as noted above and on being searched recovered the above noted articles from his house. On being asked he confessed his guilt that he is selling the same in house since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 19.25hrs to 19.45 hrs). As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Sukdev Tarafdar (23 years) s/o- Late Bimal Tarafdar of Vivekananda nagar, near masjid, ward no-42, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Sukdev Tarafdar (23 years) s/o- Late Bimal Tarafdar of Vivekananda nagar, near masjid, ward no-42, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for investigation.


