Sir,

I **Miss Payel Banerjee**, Daughter of Late Prabir Banerjee, Resident of Mangal Pandey Sarani, East Vivekananda Pally, P.O. - Rabindra Sarani, P.S. - Bhaktinagar, District - Jalpaiguri, Pin- 734006, would like to inform you as follows:-

1. That on 31.10.2022, I started to work at Samriddhi Global Consulting, where I was appointed as Chief Coordinator. During my work period I have communicated with many candidates in my official capacity and after discussion with the owner of Samriddhi Global Consulting namely Anirban Sengupta the said candidates submitted their relevant documents and required fees as per criteria for getting the required job.

2. That subsequently on 31.01.2023 I resigned from my job and I started to work as an agent of Samriddhi Global Consulting. Subsequently on 14.03.2023 suddenly Dipson Gurung, S/O Shri. Karna Kumar Gurung, of Mangpoo-734313 called me over telephone and threatened me to come to the office of Samriddhi Global Consulting otherwise they will come to my house and beat me, thereafter I went to the office of Samriddhi Global consulting at about 09.45 A.M. and when I reach there some candidates along with some local anti social persons started to threatened and abuse me with filthy languages. At that time when I tried to protest them that I am only the agent of Samriddhi Global Consulting and I have no liability towards them, then the said candidates started to molest me and touched my private parts and also threatened me that if I don't support them then they will rape me and kill me. Subsequently out of fear I could not lodge a written complaint against the said persons.

3. That thereafter I came to know that some candidates lodged one F.I.R. vide Bhaktinagar P.S. Case No. 194 of 2023 against Anirban Sengupta and as such I was an ex employee of the said consultancy I was also interrogated and as such I have convinced some candidates and referred them to Samriddhi Global Consulting they also raised allegation against me. Thereafter I obtained bail from Ld. C.J.M. Court at Jalpaiguri and the said matter is under investigation at present.

4. That now the below named candidates are constantly threatening me and abusing me in filthy languages and also threatening me that they will rape me and defame me in every aspect so that I could not be able to get any job in Siliguri. The name of the above mentioned persons are given below:-

I strongly anticipate that the said accused persons were trying to kill me or rape me and take their revenge from me. Now I am in very much fear of my life, dignity and modesty and anything may happen to me or my family due to the said accused persons.

Therefore under the above mentioned circumstances I request before your good self to kindly look into the matter and provide me the shelter of Law, otherwise they may kill me and my family at any time as they are very much desperate in their activities and for this act of kindness I shall remain extremely grateful to you.
