I am producing herewith one accused namely Chotan Sarkar alias Ramesh Sarkar (M/21 years) S/O Lt Sankar Sarkar of Samarnagar Battola PS Pradhannagar Sir, Darjeeling (not verified) along with the following articles under proper seizure as per seizure list;

a) 21 (Twenty one) bottles of WINCEREX-T Cough Syrup, each bottle containing 100 ml syrup, out of which each 5 ml Syrup contains 10 mg codeine Phosphate, Manufactured by WINGS PHARMACEUTICALS Pvt. ltd, Baddi, HP, having Batch no. WNTS 3050, Mfg July 2023, Exp. DEC 2024, - Marked as Exhibit A

b) 01 (one) bottle of WINCEREX-T Cough Syrup, each bottle containing 100 ml syrup, out of which each 5 ml Syrup contains 10 mg codeine Phosphate, Manufactured by WINGS PHARMACEUTICALS Pvt. ltd, Baddi, HP, having Batch no. WNTS 3050, Mfg July 2023, Exp. DEC 2024 taken out from Exhibit A and marked as Extibit'A-1'.

c) 01 (One) black colour backpack, having branding American Tourister, containing exhibit A which was carried by accused Chotan Sarkar alias Ramesh Sarkar (21 years) S/O Lt Sankar Sarkar of Samarnagar Battola PS Pradhannagar Dist Darjeeling on his back

I, SI Chetan Dangal (29), S/O- Mohan Kumar Dangal of Pradhan nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Chotan Sarkar alias Ramesh Sarkar (21 years) S/O Lt Sankar Sarkar of Samarnagar Battola PS Pradhannagar Dist Darjeeling (not verified) to the effect that on 21.08.2023 at about 19.05 hrs received one specific source input that one person possessing huge quantity of 'Codeine Phosphate' based drugs at Himachal Colony under Pradhan Nagar P.S jurisdiction to sell the same to his designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 1219/23 dated 21.08.2023 and subsequently, I informed the matter to the inspector In charge, of Pradhan Nagar Police Station in written and being directed, I along with ASI Manoj Kr Roy, C/762 Majibul Rahaman, CV 128 Ajay Kumar sahani, CV 223 Swapan Chettri, CV 645 Pankaj Gupta all of Pradhan nagar PS, SPC along with investigation kit left for Himachal Colony PS Pradhan Nagar Dist Darjeeling by Govt. vehicle bearing no WB 74 AC 9851 to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1220/23 dated 21.08.2023 and M.C.C No- 2082/23 Date- 21/08/2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On reaching Himachal Colony under Pradhannagar PS I contacted two persons namely 1) Sonu Sing S/O Sumit sing of Rajendra nagar Cooliepara ward no 01 PS Pradhan nagar Dist Darjeeling 2) Rupam Sharma S/O Lt Arjun Sharma Veerjawan Gurung busty ward no 02 PS Pradhannagar Dist Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter, we along with above noted independent witnesses arrived at Himachal Colony under Pradhan Nagar PS at 19.55 hrs and subsequently, being pointed by my

source detained 01 (one) suspect person carrying one black colour backpack on his back supposed to be containing illicit drugs. Thereafter, we disclosed our identity and the information in hand and stated him as well as the bag under his possession will be searched and I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions. Consequently, I informed the matter to I/C Pradhan nagar PS and as per his kind order, I informed to Shri Narendra Kalikota , Assistant Commissioner of Police, Special Branch Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person and requested him to come at Himachal Colony under Pradhannagar PS to remain present and to supervise the search and seizure process.

Accordingly at 20.35 hrs Shri Narendra Kalikota , Assistant Commissioner of Police special branch Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot and in presence of two independent witnesses I searched the detained person following all formalities, keeping their decency and recovered 21 (Twenty one) bottles of WINCEREX-T Cough Syrup, each bottle containing 100 ml syrup, out of which each 5 ml Syrup contains 10 mg codeine Phosphate, Manufactured by WINGS PHARMACEUTICALS Pvt. ltd, Baddi, HP, having Batch no. WNTS 3050, Mfg July 2023, Exp. DEC 2024 inside the black colour backpack carrying by the suspect Chotan Sarkar alias Ramesh Sarkar from his exclusive possession,

Further, on demand in presence of Shri Narendra Kalikotay, Assistant Commissioner of Police special branch Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, The detained person namely Chotan Sarkar alias Ramesh Sarkar failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs

beyond the prescribed limit.

Thereafter, I seized (i) 21 (Twenty one) bottles of WINCEREX-T Cough Syrup, each bottle containing 100 ml syrup, out of which each 5 ml Syrup contains 10 mg codeine Phosphate, Manufactured by WINGS PHARMACEUTICALS Pvt. Itd, Baddi, HP, having Batch no. WNTS 3050, Mfg July 2023, Exp. DEC 2024 and marked as "Exhibit- A". (ii) 01 (one) bottle of WINCEREX-T Cough Syrup, each bottle containing 100 ml syrup, out of which each 5 ml Syrup contains 10 mg codeine Phosphate, Manufactured by WINGS PHARMACEUTICALS Pvt. ltd, Baddi, HP, having Batch no. WNTS 3050, Mfg July 2023, Exp. DEC 2024 taken out from Exhibit A and marked as Extibit 'A-1' and (iii) 01 (One) black colour backpack, having branding American Tourister, containing exhibit A which was carried by accused Chotan Sarkar alias Ramesh Sarkar (M/21 years) S/O Lt Sankar Sarkar of Samarnagar Battola PS Pradhannagar Dist Darjeeling on his back the search and seizure was conducted under proper videography and in presence of independent witnesses and Shri Narendra Kalikotay obtaining their signature and being acknowledged by the accused person and labelled and sealed the seized articles in presence of Shri Narendra Kalikotay, independent witnesses and the accused person namely Chotan Sarkar alias Ramesh Sarkar. The whole process of seizure and label was made in between 20.50hrs to 21.45hrs.

Being further asked, the apprehend person namely Chotan Sarkar alias Ramesh Sarkar admitted in presence of Shri Narendra Kalikotay and other independent witnesses that he procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed local customers for his personal gain by illegal means. From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Chotan Sarkar alias Ramesh Sarkar

directly involved in procuring and selling 'Codeine Phosphate' based drugs illegally

contravening the norms of NDPS Act.

Therefore, I arrested the above noted accused person namely Chotan Sarkar alias Ramesh Sarkar after observing all formalities and informing the ground of arrest and issued necessary Memo of Arrest. Further, while making arrest the arrested person was informed about his right to inform his arrest to his relative/Family members but he failed to produced any contact no of such person, therefore, the memo of arrest was duly signed by the available witness of the locality, however intimation will be sent to his relative/ family members whoever available about the arrest of accused Chotan Sarkar alias Ramesh Sarkar (21 years) S/O Lt Sankar Sarkar of Samarnagar Battola at the earliest.

Under the above circumstances, I am praying to you that a specific case under proper section of law may kindly be started against above noted Chotan Sarkar alias Ramesh Sarkar (21 years) S/O Lt Sankar Sarkar of Samarnagar Battola PS Pradhannagar Dist Darjeeling (not verified) and arrange for its investigation.
