After hitting the scooter both were fall down from the scooter and bled injuries, local people brought them to Maharaja Agrasen Hospital where Smt NAINA AGARWAL declared as "Brought Dead".

So its a humble request you to take a necessary action against the driver of the vehicle NO WB 73E3795 also launch a FIR on the same.
