Sir,

In producing herewith arrested accused person namely Biswajit Modak (Male/27 yrs), S/O- Kartick Modak of Vill. Khai Khai bazar, Ward no. 41, PO. Sevoke road, PS- Bhaktinagar, Dist. Jalpaiguri under arrest along with the following seized articles i.e

- (i) 10 (Ten) Bottles of "Himalayan GOLD" 60 UP Country spirit and each bottle contains 600 ml.
- (ii) 07 (Seven) Bottles of "Himalayan FATA FATI" 70 UP country made spirit each bottle containing 300 ml,
- (iii) 04(Four) Bottles of "KACHI" 70 UP country made spirit each bottle containing 300 ml,

I, PSI Koushik Raha presently posted at Bhaktinagar P.S, Dist Jalpaiguri lodge this written complaint to the effect that on 23.08.2023 myself and forces were detailed for mobile van duty vide Bhaktinagar PS GD entry No. 1270, dated 23.08.2023. During duty at 18.35 hrs myself received secret source information that some illicit liquor are carrying/selling illegally from Sevoke road area. At once I informed the matter to I.C. Bhaktinagar PS about the details of the information. Then, as per his permission, myself along with C/374 Debraj Biswas, C/1426 Prasanta Kumar Dutta ,CV/619 Dharmendra Roy and others left for work out the information. On reaching at Sevoke road near P.C. Mittal Bus stand myself and forces apprehended one person who are carrying a bag which contain country spirit bottles. On searching, we found total 1) 10 (Ten) Bottles of "Himalayan GOLD" 60 UP Country spirit and each bottle contains 600 ml, 2) 07 (Seven) Bottles of "Himalayan FATA FATI" 70 UP country made spirit each bottle containing 300 ml, 3) 04 (Four) Bottles of "KACHI" 70 UP country made spirit each bottle containing 300 ml. We found the person who stated that he is running this business and sell illicit liquor/country spirit without any licence or valid document among the local drinkers. On interrogation he disclosed his identity as Biswajit Modak (Male/27 yrs), S/O- Kartick Modak of Vill. Khai Khai bazar, Ward no. 41, PO. Sevoke road, PS- Bhaktinagar, Dist. Jalpaiguri. On further interrogation he stated that he is involved in illegal selling with the above mentioned liquor article from sevoke road to make good profit. On physical verification the above noted accused person failed to produce any valid documents in respect of selling the said illicit liquor articles.

Subsequently, in presence of witnesses myself prepared a seizure list of the above noted articles under proper seizure. The whole processes of search and seizure made in between 19.15 hrs to 19.40 hrs and arrested above noted accused person after preparing arrest memo stating the ground of arrest.

Therefore, I request before you that a specific case against the accused person namely Biswajit Modak (Male/27 yrs), S/O- Kartick Modak of Vill. Khai Khai bazar, Ward no. 41, PO. Sevoke road, PS- Bhaktinagar, Dist. Jalpaiguri may kindly be start under proper sections of law and arrange for its investigation.
