Respected Sir,

I, Smt. Rina Sahani, W/o Late Raj Kumar Sahani, r/o Rajendra Nagar, Collipara, Ward No. 1 of SMC, Siliguri, would like to inform you that today i.e. 23.08.2023 at about 9 p.m. my sister namely Kabita Sahani has been discussing with some personal matter with Nilam Yadav, in the compound of hanuman mandir situated in the Coolipara area at that relevant point of time Rajesh Sahani, Rohit Sahani, Sumit Sahani, Chandan Sahani, Tota Sahani and Punam Sahani all are residence of Rajendra Nagar Coolipara, Ward No. 1 of SMC, Siliguri was coming on that side at that time with full motive and suddenly started abusing with filthy languages to my sister i.e. Kabita Sahani. On protest they started assaulting Kabita Sahani with Fist and blows by which she got injury on her person by seeing the said incident I rushed to the spot to help my sister i.e. kabita Sahani. At that time all these six miscreants i.e. Rajesh Sahani, Rohit Sahani, Sumit Sahani, Chandan Sahani, Tota Sahani and Punam Sahani suddenly started assaulting me with fist and blows and with iron rod, Hockey Stick and other weapons in my head and other part of my body by which I got severe injury on my head and other part of my body and due to injury I became unconscious for some time and thereafter was treated to Siliguri District Hospital. It is also pertinent to mention here that during the period of confrontation my brother namely Raj Sahani when reached the spot for settling the matter at that time these Six culprits severally assaulted him and has done without any proper reason and he also became severe injured and subsequently treated in the said hospital.

Sir, after the incident they are threatening us that if we lodge any complaint to any authority/Police Station then they will kill us. Now we became very shaky and afraid that they are very furious in nature and any untoward incident may happen in any time so, I am requesting you to take immediate action against these six culprits and properly investigate the matter from your end and accordingly punish the miscreants as per provision of law.
