Sir,


I SI MD. Ziaul Haque (43), s/o Md Reazul Hoque of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 23.08.23 around 15.30 hrs, while on duty at Court More area found one (1) TOTO without any registration number stationed near Court More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Subhas Das (48 Yrs), S/o- Lt. Nilu Das of Purba Majhabari, PS-Bhaktinagar, Dist Jalpaiguri. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road but he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
