That after our marriage we live happily, on 16<sup>th</sup> June 2019 our child born, after the birth of our child he started behaving differently. After some time he send me to my parents house and told me he will take me back but even after three months he did not take me back. I used to call him every day and night but he did not pick up and majority time his phone was busy.

After some time I come back to my in-laws house by myself. And after that my husband started abusing me and every night one lady namely Gopa Basak used to called him and they talked more than an hour. When I asked him about the matter he told me that is his personal matter and without any reason he beat me.

All this matter used to happen everyday and one day he told me he had an affair with another woman namely Gopa Basak and he did not want to live with me and my son. And he send me to my parents house. I request him many times that I want to live with him

From 2020 I live separately in my parents' house. Then I started working in a private office and from then I look after my child and myself. And my husband did not take any information about us.

But suddenly from last six months he started calling me and told me, that lady Gopa Basak leave him and now he wanted to live with me, when I refuse him, he started threaten me over phone.

Now the level of his torture took its extreme level, every night he came to my house and abuse me. Sometimes he came in drunk situation and shouted in front of my house. He threats me over phone that he will kill my child and my parents and after that he will kill me. Yesterday in Millampally he stopped me in road and slap me and threat me that if I came out from my home he will definitely kill me.

Right now I am very much afraid, my life is in danger and my parents are also afraid, we are helpless he can come to my house any time.

Therefore I request you to take an immediate step. I have no other option. kindly take necessary step for the end of justice.
