Having come to know regarding the fact few of my fellow mates came to the spot and rescued me and immediately rushed me to Siliguri District Hospital where my treatment is still in progress and admitted till now.

Therefore its my earnest request to vigil into the matter seriously and do recover my belongings and also do take serious action against the above named persons mentioned above for which I would be grateful enough.
