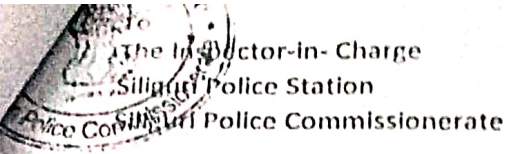

Sub:- Written complaint against 01(one) Driver of plying illegally at Venus More without any valid documents causing obstruction to public way.

Sir,

I SI Pintu Kr. Mandal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 25.08.23 at around 12.30 hrs, while on duty at Venus More found one (1) TOTO without any registration number stationed near Venus More flyover approach in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Uday Goswami (29 yrs) S/O Kirtibas Goswami South Colony, NJP, Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they fail to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law as deemed fit against the said person with necessary action as applicable.
