Subject Brief: Complaint against **Md. Roushan** (S/O Md. Salimuddin, Resident of Home No. 128, Tarijote, New Choudhury Pukur, P.O. New Rangia, PS. Matigara, Darjeeling) and **his gang/hooligans for trying to encroach on our Khatian land illegally** with the sole motive to take possession by using their muscle power and not allowing us to enter our land and creating violent chaos and conflict- **Request legal action thereto.**

Respected Sir,

With due regards, concerning the above subject matter, I, on behalf of the following four Land-Owners, would like to inform you that we are the owners of side-by-side **four different plots of Kahatian land at Tari Mouza** (Opposite Sacred Heart School), **under P.S. Matigara, Dist. Darjeeling**, West Bengal, for a long. The details of the said four plots are represented in the following table for clear information and visibility-

Now the issues are stated below:


- (i) Without informing anything to us; in the second and third week of June 2023, **Md. Roushan**, along with his associate relatives/goons, has fenced the land of all four plots of ours at entry level, and now they are not allowing us to enter our land in any way and creating violent chaos and conflict.
- (ii) We asked him and his kins and associate goons why they fenced our land and are not allowing us to enter the land, but he and his kins and goons have not given any explanation but rather made violent chaos and conflict.
- (iii) We observed not only **Md. Roushan**, his relatives and associate goons like him insisted on making chaos, conflict and violence. In addition, we came to know that **Md. Roushan** is a renowned **Land Mafia**.

- (iv) Among the four landowners, **Dr. Samar Kumar Biswas** and **Dr. Lovely Sarkar** are the **Professors**, **Smt. Anima Ray** is a 73-year-old **Retired School Teacher** and, on behalf of the Late Gopal Ch. Dutta, his son, Mr Uttam Dutta, is a businessman. As per our profession, age and position, we avoid all kinds of chaos, conflict and violence, so we stop there to argue with them.
- (v) It is known that **Md. Roushan**, S/O Md. Salimuddin is the Resident of Home No. 128, Tarijote, New Choudhury Pukur, P.O. New Rangia, PS. Matigara, Darjeeling. Further, some of his relatives and associates etc., also live in the same locality.
- (vi) We have all the papers and documents related to the said four land plots.
- (vii) Given that, we would request you to kindly intervere in the matter to solve the problem immediately; otherwise, people like us will be helpless, and our hard-earned land property will be grabbed by them in this way, and it will be increased day by day which must lead the maximum disorganization, conflict and violence.

I, therefore, earnestly request you take the necessary action in this regard so that we may be able to use the land without any difficulty and discomfort.


