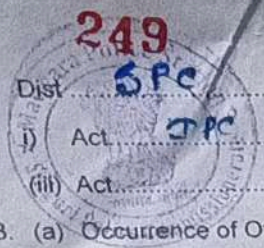

Sir,

In producing herewith 07 (seven) arrested accused persons namely (i) Darpan Lama (28) S/O Dorjee Lama of No. 3 More, Patharghata, PO- New Chumta, PS-Matigara, Dist- Darjeeling (ii) Adarsha N. Singh (29) S/O Pius Singh of Bich Goan St. Marry's Hill, PS-Kurseong, Dist- Darjeeling- (iii) Nishan Gurung (21) S/O Bijoy Gurung of Jungpana T.E., PS-Kurseong, Dist-Darjeeling (iv) Ronak Rai (19) S/O Rabin Rai of Singell Kothidhura T.E. PS- Kurseong, Dist-Darjeeling (v) Antim Subba (21) S/O Lt. Karna Bahadur Subba of Thulogoan Sepaidhura, T.E. PS- Kurseong, Dist-Darjeeling (vi) Nikesh Tamang (21) S/O Ranjan Tamang of 20th Mile Tindharia, PS-Kurseong, Dist-Darjeeling and (vii) David Pradhan (20) S/O Kishor Pradhan of Jogmaya T.E. PS- Kurseong, Dist-Darjeeling (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

- (1) One iron made 'Knife' found from the exclusive possession of Darpan Lama which was kept in his right hand.
- (2) One iron made 'Crowbar' found from the exclusive possession of Adarsha N. Singh which was kept in his right hand.
- (3) One iron made 'Bhojali' found from the exclusive possession of Nishan Gurung which was kept on his left hand.
- (4) One 'iron rod' measuring approximately 3 feet found from the exclusive possession of Ronak Rai which was kept in his right hand.
- (5) One 'torch light' found from the exclusive possession of Antim Subba which was kept in his left hand.
- (6) One 'iron rod measuring approximately 3.5 feet found from the exclusive possession of Nikesh Tamang which was kept in his right hand.
- (7) One 'iron sword' measuring approximately 4 feet found from the exclusive possession of David Pradhan which was kept in his left hand.
- (8) One new white colour Tata Altroz vehicle without number plate .

I, ASI Dhirendranath Mandal of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Darpan Lama (ii) Adarsha N. Singh (iii) Nishan Gurung (iv) Ronak Rai (v) Antim Subba (vi) Nikesh Tamang (vii) David Pradhan and others to the effect that today on 26/08/2023 at 00:45 hrs received a source information that 10/12 youths have assembled at the house of Bharat Bhushan of Simultala under Matigara PS with a view to commit dacoity in a house at Simultala under Matigara PS. Subsequently, after sharing the information with my superiors and as per their direction, I along with SI Sailesh Subba, C/523 Sanjit Kundu, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, and CV/977 Ganesh Paswan all of Matigara PS, SPC, left for the place to work out the information. At about 01:45 hrs after reaching near the house of Bharat Bhushan at Simultala under Matigara PS, I met my source and being pointed by the source we started walking towards the house of Bharat Bhushan. At 02:25 hrs we reached near the house of Bharat Bhushan and started cordoning off the area as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot. Seeing police personnel approaching towards them they tried to flee away, but on hot chase we managed to apprehend above noted 07(seven) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation all the accused persons admitted that they had assembled there to commit dacoity in a house at Simultala.



I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was made in between 03:00 hrs to 03:35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Simultala. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely (i) Darpan Lama (28) S/O Dorjee Lama of No. 3 More, Patharghata, PO- New Chumta, PS-Matigara, Dist- Darjeeling (ii) Adarsha N. Singh (29) S/O Pius Singh of Bich Goan St. Marry's Hill, PS-Kurseong, Dist- Darjeeling- (iii) Nishan Gurung (21) S/O Bijoy Gurung of Jungpana T.E., PS-Kurseong, Dist-Darjeeling (iv) Ronak Rai (19) S/O Rabin Rai of Singell Kothidhura T.E. PS-Kurseong, Dist-Darjeeling (v) Antim Subba (21) S/O Lt. Karna Bahadur Subba of Thulogoan Sepaidhura, T.E. PS-Kurseong, Dist-Darjeeling (vi) Nikesh Tamang (21) S/O Ranjan Tamang of 20th Mile Tindharia, PS-Kurseong, Dist-Darjeeling and (vii) David Pradhan (20) S/O Kishor Pradhan of Jogmaya T.E. PS- Kurseong, Dist-Darjeeling and others and arrange for its investigation.
