Sir,

In producing herewith two arrested accused person namely (1) Monu Roy (21) S/O Sri Rajesh Roy of Shantipara, PO- Sahudangihat PS-New Jalpaiguri, Jalpaiguri and (2) Kartik Roy (20) S/O Lt Congress Roy of do along with original seized list and seized articles i.e (i) One Green colour Hero brand bicycle with backside carrier and (ii) One Black colour Hero brand bicycle with backside carrier and other relevant papers.

The fact of the case in brief is that I, ASI Anupam Roy of North Bengal Medical College & Hospital OP under Matigara PS SPC do hereby lodge a written complaint against the above noted two accused persons named (1) Monu Roy (21) S/O Sri Rajesh Roy of Shantipara, PO- Sahudangihat PS-New Jalpaiguri, Jalpaiguri and (2) Kartik Roy (20) S/O Lt Congress Roy of do to the effect that today on 26/08/2023 I along with C/1085 Mithun Debnath and VP-06 Nitish Singha of NBMC OP were performing evening mobile van duty vide MCC No- 1062/23 dated 26/08/2023 and NBMC OP GDE No-705 dated 26/08/2023. During my evening mobile van duty at 20:25 hrs I received secret source information that two persons are waiting at Gaishal Shamshan Ghat with two stolen Bicycle for sale the same for their illegal gain. Accordingly I informed the information to OC NBMC&H OP over telephone and as per his direction I along with C/1085 Mithun Debnath and VP-06 Nitish Singha left for PO to work out the information. On arrival at Gaishal Shamshan Ghat at 20:35 hrs being pointed out by the source, we apprehended two persons as mentioned above and recovered two nos of Hero brand bicycle from their possession. On demand they failed to produce any documents in support of said two nos of Bicycles. On further interrogation they confessed that, few days ago they stolen the above mentioned two Bicycles from Kawakhari area and today they came here for sale the same for their illegal gain.

Accordingly I seized the said two nos of bicycle i.e (i) One Green colour Hero brand bicycle with backside carrier and (ii) One Black colour Hero brand bicycle with backside carrier under proper seizure list. The seizure was made in between 20:55 hrs to 21:15 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against them.

Under the above circumstances I am submitting this written complaint against the above noted two accused persons namely (1) Monu Roy (21) S/O Sri Rajesh Roy of Shantipara, PO- Sahudangihat PS-New Jalpaiguri, Jalpaiguri and (2) Kartik Roy (20) S/O Lt Congress Roy of do for starting a specific case under proper section of law and to arrange for its investigation.
