Respected Sir,

With due respect I, **SRI YOGRAJ BAREJA**, Son of Sri Harichand Bareja, Resident of Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to lodge this written complaint to the effect that I am a small businessman and I have been carrying on a business of handloom as a sole proprietor of "Rajasthan Handloom Store" on and from Alupatty, Siliguri. Sir, previously I got married with Smt. Tara Chhetri and our said marriage was solemnized on 11.12.2005 but ed on 26/08/29 due to differences of opinion, we have started to live separately on tres vide PDN our mutual consent since in the year of 2015 and finally, our said No. 1457 and marriage was dissolved on our mutual consent.

On 15th April, 2021, I had visited the City Centre, Matigara U/s 148,333, and I also visited the shop of Spencer at City Centre, Matigara for purchasing some materials and during my visit at Spencer, City to Centre, Matigara, I got acquainted with one lady who introduced herself as UTTARA ROY and during our conversation, we have exchanged our mobile numbers and thereafter, we used to talk with each other and share our feelings. After that, said Smt. Uttara Roy has started to visit at my shop at Alupatty, Siliguri and used to pass her time at my shop as per her own wish and during our conversation, she also narrated before me that she is a divorcee and her marriage was solemnized with one Sri Lalit Choudhury of Maynaguri few years back and out of her said wedlock, one female child namely Miss Riya Roy and one male child namely Master Barun Roy were born and they are resided with her and out of her small income, she has been maintaining herself as well as her two children in a financial hardship. She further states that her earlier marriage has already been dissolved and in fact, there is none to look after her as well as her two children.

On 22nd August, 2021, while we were having conversation, she requested me to shifted herself as well as her two children in my flat as she is not in a position to afford the rent of the tenanted premises and considering her said request, I allowed her as well as her two children to stay in flat. After staying two months in my flat, suddenly she told me that she does not want to stay in my flat and wanted to shift in a rented house and requested and demanded a sum of Rs. 12,000/- only from me for household usage and considering her said request and demand, I have paid the said amount to her. It is to be mentioned here that immediately after

enter into my flat, she took one key of the said flat in her possession and another key is in my possession.

On 24.10.2021, she came to my flat with her friend and took away all her belongings with her and thereafter, again after two days, she return back to my flat with her belongings and informed me that as misguided by some of her friends, she left the flat and in near future, she will not done any mistake and expressed her desire to stay again at my flat with her two children and thinking her said condition, I allowed her to stay at my flat. After staying few days in my flat, she insisted me to marry her as there is none to look after her as well as her two children and considering the said situation, I have also agreed to marry her and accordingly, on 19.01.2022, I married with said Smt. Uttara Roy in a Kalibari at Champasari, Pradhan Nagar, in front of our friends and after our said marriage, we have started to reside together as husband and wife and since the date of her entry in my flat, I took all the responsibilities for her maintenance as well as for the two children and I also took all the responsibility towards welfare and proper education of both the children as my own.

After few months of our said marriage, my wife Smt. Uttara Roy has started to create pressure upon me and also forced me to transfer the said flat in her name. It is very much within her knowledge that I have purchased the said flat with the financial assistance of Bank and month by month, I have been paying the EMIs to the concerned Bank and until and unless, the said loan has repaid, I am not legally entitled to transfer the same in her name but inspite of having the knowledge about the said fact, she constantly created pressure upon me. Thereafter, she started to create pressure upon me by saying that she does not want to stay with me and for that purpose, I have to pay more than a sum of Rs. 12,00,000/- only to her and also threatened that if I fail to pay the said amount, she will not hesitate to implicate me in a false criminal case. Day by day, her demand has been increased and later, she started to threaten me that if I fail to pay the demand amount to her, she will not hesitate to put me behind the iron bar for a long period incorporating a manufactured allegation involving with her minor daughter. She also threatened me that if I fail to fulfill her said demand, she will not hesitate to ruin the life of my own daughter by throwing acid upon her.

Sir, since the date of her entry in my flat, I gave proper honour to her as well as her two minor children as my own children but she treated me as her money making machine. Now a day, she started to threaten me by saying that she will commit suicide and thereby, ruin my entire career. Not only that, she also restricted me to make any contact with my parents and other family members. It is also required to mention here that during our first conversation, she told me that during the period of COVID - 19, she has/have no job and

for that purpose, she took personal loan from different persons to the tune of Rs. 1,90,000/- only for her own requirement and she has failed to repay the said amount to those persons and the persons from whom she has taken the loan, they are creating pressure upon her and narrating the said story, she asked me to help her to repay the said amount and after hearing the same from said Uttara Roy, I have given a sum of Rs. 1,90,000/- only within the month of August, 2021 to December, 2021. Every day, she has placed a new demand upon me and if I fail to fulfill her said demand, she started to pick up quarrel with me and also started to threaten me with dire consequences. Sir, if such type of torture is being continued, I have no other option to ruin my own life by way of committing suicide. It is also to be mentioned here that though we are living in the same flat but since in the month of April, 2022, we are living separately in a same flat and never share the same bed.

Recently, I came to learn that her earlier marriage is still existing and subsisting and suppressing the said fact, she entered into marriage with me with an intention to squeeze money from me illegally and her husband namely Sri Lalit Choudhury is residing at Maynaguri within the District of Jalpaiguri.

Thereafter, finding no other alternative, I have filed an application U/S 13 of Hindu Marriage Act, 1955, against said Uttara Roy which is still pending before the Court of Law and during pendency of the said case, again said Smt. Uttara Roy came before me with an approach to settle the disputes amicably and she also put a demand of Rs. 15,00,000/- only towards her maintenance as well as the maintenance of her children and considering her said approach, I have agreed to settle the disputes with her amicably on humanitarian ground and accordingly, a Deed of Mutual Agreement was prepared and executed in between myself and said Smt. Uttara Roy and as per the Deed of Mutual Agreement, I have paid and transferred the total demanded amount of Rs. 15,00,000/- (Rupees Fifteen Lakhs) only to her which she acknowledged the same as having received and the said amount was paid through cash as well as by way of Cheque/s and since then, we have relinquished our respective relation with each other and both of us have been living separately.

**Suddenly on 24.08.2023 at about 09.00/09.30 A.M., said Smt. Uttara Roy came to my flat situated at Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and knock the door and immediately after opening the door, I found that she is standing in front of my flat and started to quarrel with me without any just cause and reason and when I made protest against her such type of behaviour, she started to assault me physically and also snatched my mobile phone (Redmi - having No. 93321-82138 & 86170-15552) and also snatched the Key of my bike**

*forcefully and also started to abuse and threaten me with dire consequences. It is to be mentioned here that I have been maintaining Google Pay, PhonePe & PayTM Account in my said mobile phone with my registered Mobile No. 93321-82138 and said Smt. Uttora Roy may access the said Account as she is well acquainted with the PIN of those Accounts and during the said time, the other flat owners also gathered there and they saw the said incident and due to their intervention, after some time, said Uttora Roy left the place and at the time of leaving the place, she again threatened me that she will come again in the aforesaid premises as well as in my shop as and when she desires and nobody will do anything against her and it is my strong believe that she has done all these things with an intention to squeeze more money from me.*

*I, therefore, request you to kindly investigate into the matter and please take appropriate legal action against said Uttora Roy after treating my present complaint as an FIR as per the provision of law and oblige thereby.*
