Respectfully I, would like to inform you that I, **Smt. Uttara Roy**, W/o Sri Yograj Bareja, Hindu by faith, Housewife by occupation, r/o Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling, and also do hereby lodging this written complainant against my husband namely **(1) YOGRAJ BAREJA**, S/o Sri Harichand Bareja and **(2) my husband's first wife's daughter namely Miss Manika Bareja**, D/o Yograj Bareja and **(3) my husband's first wife namely Smt. Tara Chhetri** ^{her} ~~whose~~ finally her marriage was already dissolved on their Divorce by mutual consent, No. 1 resident of Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling and No.2 and 3 resident of Milan More, P.O. Champasari, P.S. Bhaktinagar Dist. Darjeeling.

That on 19/01/2022 my marriage was solemnized with one **YOGRAJ BAREJA**, S/o Sri Harichand Bareja, as per Hindu Rites and Customs, r/o Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling, Pin Code- 734003. (Colour Photograph of marriage ceremony and one deed of mutual agreement is enclose herewith).

That since after my marriage we are living as a husband and wife peacefully and since marriage we are leading our conjugal life as husband and wife at Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling.

That since after my marriage, my husband **Yograj Bareja** along with my husband's first wife's daughter **Miss Manika Bareja** and my husband's first wife, who has been already divorcee **Smt. Tara Chhetri** are started torturing me both physically and mentally and both are day by day came in my house at Silicon Gardinia, Debidanga, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling and they have brutally assaulted me physically and said **Miss Monika Bareja** also threatened me by saying that if I denied to file Divorce with my husband then she had been pouring acid in my

whole body and burn me alive and also threatened me if I am informed the matter to the Police then she Kidnapped my minor children,

That my husband without informing me file a Divorce case against me, And my husband's first wife daughter **Miss Monika Bareja** had also threatened me with dire consequences, She had also threatened me by saying she kill me and my body was through in the Tista River nobody can traced out myself . It is to be noted that they have intentionally making deep rooted criminal conspiracy against me.

That on 6/7/2023 they have been forcefully signed me in a some blank papers, thereafter I came to know that they have making a Deed of mutual agreement and file a Divorce Case, and thereafter I, came to know that from my husband he file an application under section 13 of Hindu Marriage Act, 1955 (Divorce Case) before the Ld. Additional District Judge, (1st Court) at Siliguri vide Matrimonial Suit No.209 of 2023. Without my consent and they have forcefully threatened me with dire consequences and they have assaulted me physically and mentally and they have making a forged documents and forcefully signed me the said documents (i.e. this deed of mutual agreement and file a divorce case against me without my consent).

That without my consent and they have been cheating with me. It is very much clear from their illegal acts they have been intentionally making deep rooted criminal conspiracy against me by making a forged documents by way of cheating against me.

Therefore I request your good office to kindly take strict legal action as per law against the accused persons namely (1) YOGRAJ BAREJA (2) MISS MONIKA BAREJA and (3) SMT. TARA CHHETRI and restrained them from mental and physical tortured me, so that I am not harassed mentally and physically from them live peacefully.

Your early action in this matter shall be highly appreciated.
