Sir,

In producing herewith three arrested accused persons viz: (1) Krishna Rajbanshi-22yrs s/o Sanatan Rajbanshi of Samarnagar Battala, near Ganga Mandir, PS Pradhannagar Dist Darjeeling (2) Kamal Thapa-28yrs s/o Gopal Thapa of Kholachand Fapri, PS Bhaktinagar Dist Jalpaiguri and (3) Md Pappu -28yrs s/o Md Mustakin of Durganagar ward No-40, PS Bhaktinagar Dist Jalpaiguri arrested on 27.08.23 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron Axe measuring about 14 inch (approx) including butt from the possession of accused Krishna Rajbanshi which was kept on his right hand.
2. One iron rod measuring about 20 inch (approx) from the possession of accused Kamal Thapa which was kept on his left hand.
3. One wooden made Hockey stick measuring about 35 inch (approx) from the possession of accused Md Pappu which was kept on his right hand.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 27.08.23 at 00.15 hrs received a sources information that 10/12 youths have assembled near Baikunthapur Forest office at Kholachand Fapri under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No- 1426 dated 27.08.23 Subsequently after sharing the information with my superiors and as per their direction, at 00.25 hrs myself along with SI Rantu Halder, SI Mrinal Basunia, PSI Chiranjit Saha, ASI Chandra Prakash Adhikary, Const/374 Debraj Biswas, Const/1426 Prasanta Kumar Dutta along with kits left for the place to work out the information. Inform night mobile van officer PSI Dipankar Roy with a request to remain present there. This refers to Bhaktinagar PS G.D.E No 1427 dated 27.08.23. We reached near Baikunthapur Forest office at Kholachand Fapri, under Bhaktinagar PS at 00.35 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 03 (three) accused persons along with seized articles as mentioned above. However, the other five persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhaktinagar PS area. They also stated that another Five others fled away from the spot..

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.35 hrs to 02.20 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Krishna Rajbanshi-22yrs s/o Sanatan Rajbanshi of Samarnagar Battala, near Ganga Mandir, PS Pradhannagar Dist Darjeeling (2) Kamal Thapa-28yrs s/o Gopal Thapa of Kholachand Fapri, PS Bhaktinagar Dist Jalpaiguri and (3) Md Pappu -28yrs s/o Md Mustakin of Durganagar ward No-40, PS Bhaktinagar Dist Jalpaiguri and five others and arrange for its investigation.
