I, Suman Sengupta, Son Of Ashoke Sengupta, Divisional Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electrical equipments, property of WBSedcl. At Around 11:30 PM on 26.08.2023 evening Power House Customer Care Center received information regarding damage of electric equipments and accessories in front of 100 Pearls, Zila Parishad Road, PO Salugara, PS Bhaktinagar, Dist Jalpaiguri, Siliguri. On reaching the site, it was found that a Vehicle, had severely damaged LT naked wire along with other accessories, the property being of WBSedcl. It was found that a truck with vehicle no NL01A E1765 (ph no- +91740707817) had damaged the infrastructure. The total damages caused by the vehicle are approximately around Rs 15012/- (Rupees Fifteen Thousand Twelve Only). Thus you are requested to kindly initiate an investigation against the culprit/s under Section 139 of the Indian Electricity act 2003 amended on 2007.
