Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Hill Cart Road (Near Sevoke More) without any valid documents causing obstruction to public way.

Sir,

I ASI Dindayal Mandal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 26.08.23 around 17.25 hrs, while on duty at Sevoke More, Hill Cart Road, one TOTO without any registration number stationed near Sevoke more, Hill Cart Road, a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained said TOTO and on being asked the driver disclosed his identity as Subhankar Das (M-9046863368) S/O- Bablu Das of Jhankar More, W.No-04, P.O-Jotinagar P.S- Siliguri, Dist- Darjeeling. Further on being asked to produce relevant documents in support of his claim of plying TOTO on Major Road he failed to produce any valid documents. Thereafter I seized the TOTO and arrested the person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case against the above person (TOTO Driver) under proper section of law from your end.
