Sir,

In producing herewith one (01) accused person named Arkoprovo Saha (M/38), S/O- Gouranga Chandra Saha of 16 Azad Hind Sarani, Subhash Pally, W/No - 20, PS. Siliguri, Dist- Darjeeling along with seized articles viz. 10(ten) bottles of HIGHBURY CLASSIC Rare Reserve Whisky Blended with Imported Malts, each bottle containing 750 ml, Total 7.5 liters, value Rs 9800/- I, SI- Uttam Kumar Baghira presently posted at Siliguri Police Station, SPC would like to lodged this written complaint against the above noted person to the effect that today (27.08.2023) at 15.35 hrs while performing K-22 Van duty, myself along with C/1493 Sumit Roy and C/1406 Biman Barman had been to Subhash Pally area received secret source information that the above noted person has stored liquor at his house. Then I cordoned the house with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the house. On being search of his house in presence of available witnesses the above noted seized article is found inside his house. On being asked he failed to produce any valid license/papers for storing of such article. Then I seized the above mentioned article under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. On further interrogation of the arrested person it could be learnt that he is involved in possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 16.15 hrs to 16.35 hrs.


