In producing herewith one accused person named Debrabrata Mohanto (40) S/o Birendranath Mahanta of Siliguri Junction Bus stand, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Total of 30 bottles of 70 UP Indian Made Liquor, styled as KACHI, each bottle containing 300ml, having price Rs. 28 each, Tola 9 Litres out of which one bottle taken as sample for examination.

I, ASI Manoj Kumar Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Debrabrata Mohanto (40) S/o Birendranath Mahanta of Siliguri Junction Bus stand, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 29.08.2023, while performing mobile van duty received a source information at around 23:20 hrs. that one person has been selling huge quantity of illegal liquor at one shop at Champasari Road under Pradhan Nagar PS, SPC without any valid license.

Accordingly, I informed the matter to the I/C PS and as per his kind direction I along with CV/992 Jagadish Biswas and CV/646 Baban Das. Sahani had been to the house of the above mentioned accd. person at Siliguri junction under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that the above-mentioned person was selling openly at one shop at Champasari Road under Pradhan Nagar PS, SPC.

Subsequently, I along with my force was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.

Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure and arrested the above-mentioned person named Debrabrata Mohanto (40) S/o Birendranath Mahanta of Siliguri Junction Bus stand, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 23.25 hrs. to 23.40 hrs. at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Debrabrata Mohanto (40) S/o Birendranath Mahanta of Siliguri Junction Bus stand, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
