In producing herewith 01 (one) seized one Tractor with Trolley having Regd No. WB-73-D-Sir, 7075 loaded with river bed materials as per proper seizure list.

In this regards I ASI Ashok Sarki of Bagdogra PS, SPC lodged a written complaint to the effect that on 29.08.23 at 16-25 hrs received source of information that some loaded Tractor were seen with carrying river bed materials illegally towards Kestopur side from Changa river side. Accordingly I informed the matter to you and duty officer which noted in Bagdogra PS GDE No. 1496 date 29.08.23 and as per your kind instruction myself alongwith C/875 Seshnath Jha and evening mobile van officer SI Lawang Bomzon and force proceeded to Kestopur side to verify the veracity of the information which noted in Bagdogra PS GDE No. 1497 dtd. 29.08.23. At 17-15 hrs we reached at Kestopur More and found that the above noted Tractor loaded with river materials was coming Kestopur side. I alongwith force tried to stop the vehicle at Near Kestopur More, the driver got down from the vehicle and flee away and found that the said Tractor were loaded with river materials. I try to search the Owner and driver of the said Tractor but no one appear before us. It is reason to believe that the driver of the tractor was carrying the riverbed materials by theft without any valid documents/papers illegally. During enquiry it could be ascertained that the river bed materials was loaded from Changa riverbed illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted Tractor with trolley having Regd No. WB-73-D-7075 as per proper seizure list in presence of witnesses. The seizure has been made in between 19-25 hrs to 19-55 hrs.

Under the above circumstances I pray that a specific case may kindly be started against the driver of the above noted seized Tractor and arrange for its investigation .
