Sir,

In producing herewith one accused person namely Sourav Roy-19yrs s/o Dalim Roy of Dadabhai colony, near Mahananda River, ward No-42, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 18 (Eighteen) no's of pet bottles of Himalayan Gold country spirit each bottle containing 600 ML (Total-10.800ltrs) which was packed in one big nylon hand bag.

With due respect and humble submission, I ASI Chandra Prakash Adhikary of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above noted seized articles to the effect that on 30.08.23 at 18.20 hrs while performing PS mobile van duty received a source information from Dada Bhai colony under Bhaktinagar PS that one person namely Sourav Roy was selling wine in his house for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No- 1601 dated 30.08.23. As per your kind instruction myself along with ASI Dipak Adhikary, C/374 Debraj Biswas, Const/1426 Prasanta Kumar Dutta proceeded to the PO to work out the information. At 18.45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his house. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 18.50hrs to 19.10hrs)


I therefore request you a specific case may kindly be started against the accused person namely Sourav Roy-19yrs s/o Dalim Roy of Dadabhai colony, near Mahananda River, ward No-42, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
