- I, SI Agen Lepcha, of Matigara Police Station under Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted six (06) arrested accused persons to the effect that on 28.08.2023 at about 17:25 hours received a secret source information that some persons from Assam and Delhi have come at City Centre under Matigara PS for dealing fake gold and that they will make the deal at City Centre Parking inside one vehicle bearing Registration No. WB 74BK 4409and if acted immediately they could be apprehended with said Fake Gold.

Accordingly, I informed the matter to Officer In-charge of Matigara PS,SPC and noted the fact in GD vide Matigara PS GDE No1780,Date. 28.08.2023 and as per his kind order I along with SI Goutam Mallik, ASI Dhirendranath Mondal, ASI Pema Dorjee Sherpa, C/219 Sanatan Chirtakar, C/ 1053- Paresh Rava, C/523 Sanjit Kundu, CVF/643 Animesh Royall of Matigara PS,SPC left for City Centre by Govt. vehicle to verify the veracity of the source information.

At around 17:35 hours, we arrived at City Centre under Matigara PS, contacted my source and being identified by the source we saw one Mahindra XUV vehicle with Reg. No. WB74BK/4409 parked at City Centre Parking lot and some persons inside the said vehicle. Accordingly, we cordoned the said vehicle from all sides and detained all of them. We disclosed our identity as Police Team of Matigara Police Station.

On interrogation, they disclosed their identity as 1] Sanjay Das (40) s/o Late Sanju Das of Balason Bazaar, PO New Rangia, PS Matigara, Dist. Darjeeling, 2] Darshan Sarki (32) s/o Ram Sarki of Bharnobari Tea Garden, PO Hasimara, PS Jaigaon, Dist. Alipurduar, 3] AmarChand Maheshwari (57) s/o Late Parma

Lal Maheshwari of Marwari Patti, A.T Road, PO+PS Nagaon, Dist. Nagaon, Assam, 4] Jetaram Kumawat (53) s/o Late Lichaman Kumawat of Marwari Patti, PO+PS Nagaon, Dist. Nagaon, Assam and 5] Murli Dhar (40) s/o Late Ramji Lal of 10/123, West Azad Nagar, Samdung Bhawan, PO+PS Krishnanagar, East Delhi.

We told them that we had specific information that they were making a deal involving false gold to cheat their customers. They initially denied having possession of any of fake gold. Then we told them that we intended to search the vehicle in presence of witnesses as we had specific information as told to them earlier. All of them then disclosed that they have kept some fake gold biscuits concealed beneath the seat.

Leading to their statement, I searched the vehicle in presence of witnesses and recovered the

following articles:-

One Hundred and Fifteen (115) Pieces of golden color rectangular biscuits with the inscription (i) and "CREDIT SUISSE 10 gm FINE GOLD 999.9 ESSAYEUR FOUNDEUR" on one side and an image of a woman on the other side. Each biscuit weighs 10 gms. Total weight of 115 pieces is 1kg.150 gms. seized from their joined possession.

Three (03) Pieces of golden color rectangular biscuits with the inscription and "CREDIT SUISSE 50gm FINE GOLD 999.9 ESSAYEUR FOUNDEUR" on one side and an image of a woman on the other side Each biscuit weighs 50 gms. Total weight of 03 pieces is 150 grams

seized from their joined possession.

On further enquiry they all stated that they came at Siliguri for selling/delivery of the fake Gold to their customers. They also stated that they were waiting for their customers to deliver the Fake Gold to cheat them for his wrongful gain.

Accordingly I, searched them in person and also recovered nine (09) numbers of mobile phone from

their possession.

At 19.05 Hrs 1, sent ASI Dhirendranath Mondal along with requisition before Gold Smith to verify

the genumeness of recovered Golden Colour Biscuits.

At 19.25 Hrs one Goldsmith namley Rajesh Kumar Gupta s/o Late Goutam Prasad Gupta of Fumbajote, Matigara c/o Alka Gold House Jewellers, matigara Bazaar, PS Matigara, Dist. Darjeeling came at the spot and checked the quality and genuineness of the recovered Golden Color Biscuits and certified the same as fake/duplicate.

Accordingly, I seized the above noted articles along with Vehicle under proper Seizure list. I also arrested them under proper memo of arrest and also arrested the above noted four persons after observing

all the formalities of arrest. The seizure was made in between 20.35 hours to 21.45 hours.

On interrogation the accused Sanjay Das and his associates stated that they have procured the seized fake Gold Biscuits from one Tshering Bhutia, a resident of MIG Building Uttorayon. Accordingly, we held raid at the house of said Tshering Bhutia and recovered the following articles:

Two Hundred and Fifty Six (256) golden colour rectangular biscuits, each weighing 10gms

One Gold Color Chain weighing approx 70 grams (11)

One Gold Color Chain weighing approx 20 grams, (111)

One Gold Colour chain weighing approx 28 grams. (iv)

on further interrogation he stated that he has procured the same illegally from Kolkata with a view to sell and cheat the same to his designed customer by illegal means. He also disclosed that he has kept some Fake Gold Biscuits inside his vehicle.

As per his leading statement I searched his vehicle having Registration No. WB/74/BD/9567 and recovered (i) One Hundred Five (105) Pieces of sealed golden color rectangular biscuits each biscuits 50gm

in between 22.35 hours to 23.25 hours.

The accused persons confessed that they are involved in this activity since long and that they had cheated of people by selling them fake gold biscuits on earlier occassions. That they had come to City

There was a strong reason to believe that the above noted accused persons used to cheat illegally the Centre Mall today for the same purpose.

persons by delivering fake gold biscuit to their customers for their wrongful gain.

Under the above noted circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons (1] Tshering Bhutia (65) s/o Late Lada Bhutia of Flat No. 104, Tower No. 12, MIG Uttarayon, PO+PS Matigara, Dist.
