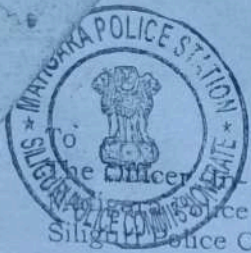

In producing herewith One arrested accused person named Nitish Chakraborty (52) s/o Late Netai Chakraborty of Indira Pally, Near Gas Godown, Shiv Mandir, PO Kadamtala, PS- Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

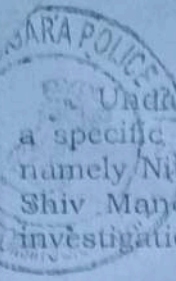
1. Twenty (20) bottles of "Himalayan Fatafati" each bottle containing 300 ml. [Total 6 Ltrs] and marked as Exhibit "A" out of which one (01) bottle of "Himalayan Fatafati" each bottle containing 300 ml taken as sample for examination and marked as Exhibit "A-1".
2. Six (06) bottle of "McDowells No. 1 Original" each Bottle containing 180 ml [Total 1.8 Ltrs] and marked as Exhibit "B" out of which one bottle of "Mc Dowells No. 1 Original" each Bottle containing 180 ml taken as sample for examination and marked as Exhibit "B-1".
3. Three (03) bottles of "Old Monk" each Bottle containing 180 ml [Total 540 ml] and marked as Exhibit "C" out of which one bottle of "Old Monk" each Bottle containing 180 ml taken as sample for examination and marked as Exhibit "C-1".

I, SI Agen Lepcha of Matigara P.S. SPC would like to lodge this written complaint against the above noted accused namely Nitish Chakrabarty (52) s/o Late Netai Chakraarty of India Pally, Near Gas Godown, Shiv Mandir, PO Kadamtala, PS- Matigara, Dist.-Darjeeling to the effect that today on 29.08.2023 at about 18.40 hrs I, received a specific source information that one Nitish Chakrabarty.(52) s/o Late Netai Chakraarty of India Pally, Near Gas Godown, Shiv Mandir, PO Kadamtala, PS- Matigara, Dist.-Darjeeling is selling illicit liquor at his shop situated at Shiv Mandir under Matigara PS.

Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1841, Dated 29.08.23 and informed the fact to the officer-In-Charge, Matigara PS and as per his kind order and direction myself along with ASI Pema Dorje Sherpa and C/1053 Paresh Rava, and all of Matigara PS left for Shiv Mandir, PS- Matigara, Dist.-Darjeeling to work out the information in hand.

After arrival at Shiv Mandir and being identified by the source we held raid at the shop of Nitish Chakrabarty and managed to apprehend him. On being asked he disclosed his identity as noted above and also disclosed that he has been selling illicit liquor at his shop without any license for his wrongful gain. Further on, being searched the above noted place recovered illicit liquor from his shop. On demand he failed to produce any valid license/papers for selling and storing of illicit liquor.

On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above noted person named Nitish Chakraborty (52) s/o Late Netai Chakraborty of Indira Pally, Near Gas Godown, Shiv Mandir, PO Kadamtala, PS- Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.05 hrs to 19.25 hrs.




Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Nilash Chakraborty (52) s/o Late Netai Chakraborty of Indira Pally, Near Gas Godown, Shiv Mandir, PO Kadamtala, PS- Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
