Sub: F.I.R

In producing herewith arrested accused person named Sambhu Munda (40 yrs), S/O - Chaitannya Munda, of - Kalam Jote, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest, seizure list and seized articles viz (I) 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 ML each @ Rs. 155/- each (totaling amount of Rs. 1550/-) marked as exhibit "A" and one bottle taken as sample.

The fact of the case is that today on 29.08.2023 at 20.25 hrs received source information that one Sambhu Munda (40 yrs), S/O - Chaitannya Munda, of - Kalam Jote, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling have stored huge quantity of ID liquor at his house illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along with ASI Krishnendu Roy, C/327 Barkat Ali Ahmed, CV 638 Partha Biswas left for Kalam Jote to work out the information. At about 20.50 hrs held raid at the house Sambhu Munda (40 yrs), S/O - Chaitannya Munda, of - Kalam Jote, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and on search 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 ML each @ Rs. 155/- have been recovered. On demand he could not produce any documents / License for possession such quantity of I.D liquor. On interrogation he admitted that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 10 (Ten) Sealed bottles of Himalayan Gold 60Up Country Spirit containing 600 ML each @ Rs. 155/- each marked as exhibit "A" and one bottle taken as sample in presence of witnesses under proper seizure memo and arrested him U/S 41 Cr.P.C. The search seizure and arrest was made in between 21.05 hrs and 21.25 hrs.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Sambhu Munda (40 yrs), S/O - Chaitannya Munda, of - Kalam Jote, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
