Sir, with due respect I beg to state that I Mr. Dhananjay Chakravarty, Son of Late Gyanem Chakravarty, residing at Vill- Netajionally, PO+Ps- Kharibari, DT- Darjeeling Pin- 734007 an employee of M/s. Pilot Industries Ltd located - Mansa Singh compound, check post, Ps. Bhaktinagar DT- Jalpaiguri. On 25-08-2023 we hired a vehicle bearing registration no: AS17C4033 (Bolero-Pick-up) through of Ghosh Roadways Transport having its office at Fullerwari, Debnandhpura, Ps- Siliguri, DT- Darjeeling for sending 100 Nos Battery from our above mention office address to M/s- Balaji Distributors, Bangaion - Assam. On 25-08-2023 at around 12:30 P.M driver of the above noted vehicle Md. Minsun Ali had loaded 100 Nos Battery from our office with all documents and then he left from our office premises for Bangaion, Assam. The date of delivery of the said Battery was on 26-08-2023. Accordingly I contacted with M/s- Balaji Distributors on 26-08-2023 at about 1:30 P.M and I came to know from them that materials still not delivered, then I try to contact with driver of the vehicle through his mobile phone. bearing phone no- 9957566260 and found switched off. Since then I failed to contact with the said driver nor he delivered the Batteries to the Balaji Distributors. I further contacted with Ghosh Roadways Transporter but he also failed to contact with the said driver.

Hence I pray before you that necessary legal actions may kindly be taken against Md. Minsun Ali, Driver of the vehicle no. AS-17C4033 and arrange to recover our said 100 Nos. of Batteries (LEADER), Model- LET-135E PLUS.
