Sir,

In producing herewith arrested accused person named Dilip Barman (M/43 yrs), S/O - Late Kebal Barman, of Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling along with copy of memo of arrest, seizure list and seized articles viz 09 (Nine) Sealed Bottles of Himalayan Gold 60 Up Country Spirit, each bottle containing 600 ML, and Rs. 155/- each bottle, totaling amount of Rs. 1395 /- and marked as Exhibit-A, out of which 01 bottle taken as sample for examination and marked as Exhibit "A-1".

The fact of the case is that today on 30.08.2023 at 18.05 hrs received source information that one Dilip Barman (M/43 yrs), S/O - Late Kebal Barman, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling have stored huge quantity of ID liquor at his house illegally for sale to the People for his wrongful gain.

I informed the matter to O/C NBMC OP and as per his direction I along with C/1085 Mithun Debnath & C/500 Mayaram Oraon left for Kawakhali to work out the information. At about 18.20 hrs held raid at the house of Dilip Barman (M/43 yrs), S/O - Late Kebal Barman, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and on search 09 (Nine) Sealed Bottles of Himalayan Gold 60 Up Country Spirit, each bottle containing 600 ML, and Rs. 155/- each bottle, totaling amount of Rs. 1395 /- have been recovered. On demand he could not produce any documents / License for his possession such quantity of I.D liquor. On interrogation he confessed that he stored the said I.D liquor illegally for sale to the interested persons for his wrongful gain.

So, I seized the said 09 (Nine) Sealed Bottles of Himalayan Gold 60 Up Country Spirit, each bottle containing 600 ML, and Rs. 155/- each, totaling amount of Rs. 1395 /- and marked as Exhibit-A, out of which 01 bottle taken as sample for examination and marked as Exhibit "A-1" in presence of witnesses under proper seizure list and arrested him U/S 41 Cr.P.C . The search seizure, label and arrest were made from 18.25 to 18.45 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Dilip Barman (M/43 yrs), S/O - Late Kebal Barman, of - Kawakhali, PO - Sushruta Nagar, PS - Matigara, Dist - Darjeeling and kindly arranged for its investigation.
