Sir,
In producing herewith 05 (four) arrested accused persons namely (i) Dipankar De (24) S/O Prasanto Debnath of Shivmandir Hallermatha, PO-New Rangia PS-Matigara, Darjeeling (ii) Md. Hamidul (32) S/O Lt. Md. Mamtaj of Matigara Biswas C, PO+PS_Matiara, Dist-Darjeeling (iii) Akash Narjinary (24) S/O Ranjit Narjinary of Himul Gate, PO-Nemai, PS-Matigara, Dist-Darjeeling (iv) Snehasis Mitra (29) S/O Partho Sarathi of Shivmandir Suryasen Pally, PO-Kadamtala, PS-Matigara, Dist-Darjeeling and (v) Pash Barman (25) S/O Naren Barman of Himul Main Gate PO-Nemai, PS-Matigara, Dist-Darj (arrested u/s- 41 Cr.P.C) along with following seized articles viz:

- (1) One iron made 'Knife' found from the possession of Dipankar Debnath which was kept right hand.
- (2) One iron made 'Crowbar' found from the possession of Md. Hamidul which was kept in right hand.
- (3) One iron made 'Bhojali' found from the possession of Akash Narjinary which was kept c left hand.
- (4) One iron rod measuring approximately 3" found from the exclusive possession of Sneha Mitra which was kept in his right hand.
- (5) One torch light found from the exclusive possession of Pashunath Barman which was 1 in his left hand

I, SI Sailesh Subba of Matigara PS, Siliguri Police Commissionerate do hereby lodge complaint against the above noted accused persons namely (i) Dipankar Debnath (ii) Hamidul (iii) Akash Narjinary (iv) Snehasis Mitra (v) Pashunath Barman and others to the that today on 31/08/2023 at 00:35 hrs received a source information that 8/10 youth assembled at Goyal More under Matigara PS with a view to commit dacoity in a house Goyal More. Subsequently, after sharing the information with my superiors and as per direction, I along with ASI Pema Dorjee Sherpa C/523 Sanjit Kundu and C/219 Sa Chitrakar, all of Matigara PS, SPC, left for the place to work out the information. At about hrs after reaching near Goyal More under Matigara PS, I met my source and being poin the source we started walking towards Goyal More. At 00:55 hrs we reached at Goyal Mo started cordoning off the suspected persons as shown by the source with a strong rea believe that they were preparing to commit some cognizable offence and were about to from the spot. Seeing police personnel approaching towards them they tried to flee away, hot chase we managed to apprehend above noted 05 (five) accused persons along with articles as mentioned above. However, the other persons managed to flee away from th taking the advantage of darkness. On interrogation all the accused persons admitted th had assembled there to commit dacoity in a house near Goyal More.

I thereafter, seized the above noted deadly weapons under proper seizure list in presence of witnesses duly acknowledged by the accused persons. The whole seizure was completed between 01:05 hrs to 01:35 hrs. Thereafter, I arrested the above noted accused persons under Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation, it could be ascertained from the arrested accused persons that they were gathered there to commit dacoity in a village at Goyal More. It is also revealed from them that some others have assembled there with arms and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of law against the above noted accused persons namely (i) Dipankar Debnath (24) S/O Prasanto Debnath of Shivmangla Hallermatha, PO-New Rangia PS-Matigara, Dist-Darjeeling (ii) Md. Hamidul (32) S/O Iqbal Mamtaj of Matigara Biswas Colony, PO+PS_Matiara, Dist-Darjeeling (iii) Akash Narjina S/O Ranjit Narjinary of Himul Main Gate, PO-Nemai, PS-Matigara, Dist-Darjeeling (iv) Sr. Mitra (29) S/O Partho Sarathi Mitra of Shivmandir Suryasen Pally, PO-Kadamtal Matigara, Dist-Darjeeling and (v) Pashunath Barman (25) S/O Naren Barman of Himul Main Gate PO-Nemai, PS-Matigara, Dist-Darjeeling and others and arrange for its investigation.
