

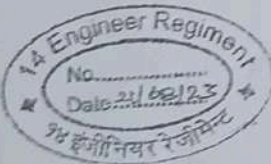

It is stated that, these theft & damage of fence is being done by local population of nearby areas because their free movement inside Sukna Military Cantonment & now being stopped after erection of this fence and thus as a retaliation they keep damaging the fence repeatedly and cause loss to Government property, which is against law and is not pardonable.

3. In view of the above, it is requested to file an FIR against such miscreants and Police patrolling of this area is also requested on regular interval. The local population needs to be warned by Police and strict action to be taken against the culprits with immediate effect.
