Pradhan Nagar, District- Darjeeling, Pin- 734003 in the state of West Bengal would like to state you that I, was in search of vacant land for residential purpose in Patharghata and nearby area. That I came into contact with one Mr. Prabir Singha, mobile no. 9064061685 resident of vill- Thiknikata, Sushruta Nagar, P.O. Sushruta Nagar, P.S. Matigara, Dist- Darjeeling, Pin-734012 in the State of West Bengal. He introduce himself as an land owner of 3 Kathas situated at Patharghata 3 number more near Wood Ridge International School and he himself showed me his land measuring 3 Kathas. After I visited the land I negotiated price of aforesaid land and after that I became ready to purchase his land total amounting Rs. 7,50,000/- (Rupees Seven Lakhs Fifty Thousand) only.

Mr. Prabir Singha assured me that he will give registry of aforesaid land on very next date i.e., on 22.02.2023. That as per his instruction I reached Bagdogra Registry Office at 11:00 am but Mr. Prabir Singha

ll return my money as soon as possible but till date he has not
n any single Penney to me and also threatened me that he will not
n my money and kill me if I continuously asked him for money and
so threatened me that he have no fear of law and no one can do
ning to him. That I have gave my heard earned money to him and for
I have been suffering from severe mental stress and not able to do
things.
