I, RATILAL SARKAR, son of Lt. Mahendra Sarkar, r/o. Vill.
Bidhanpally, Kawakhal, P.O. Sushrutanganj, P.S. Matigara,
Dist. Darjeeling, would like to inform you that RAM NATH
SARKAR, son of Sri. Ratilal Sarkar, is my elder son who
reside with me at my above mentioned residential address.
He is a car driver by profession. That today i.e. 31.08.2023
at about 4:30 P.M., while he was washing his car outside
of our residence suddenly three persons namely 1.
AKASH SUTRADHAR, s/o. Gopal Sutradhar 2. PINTU DUTTA,
s/o. Sukumar Dutta, and 3. KOUSHIK DUTTA, s/o. Bappa
Dutta, who were gathered already and having conver-
-sation nearby my house, started using slang and
abusive languages to my son. On hearing when my
son asked and requested them to refrain from using
filthy languages towards him unnecessarily, suddenly
they became furious and started to assault my
son brutally with stones on his persons. He then
cried loud for help and hearing the local people
rushed into the spot and somehow rescued him.
They immediately fled away from the spot. When I
reached at the spot my son said that the above
culprits were trying to kill him. I, with the help of
local people, took him to the hospital as he suffered
greivous head injury. Now he is under treatment.

I therefore, request you to kindly
take necessary legal steps against the above nam-
three criminals and thus render us justice.
