Sir,

I am producing herewith the following three accused namely i) Sunil Mahato @ Bholu (35) S/O Lt Sujjan Mahato of Cooliepara Rajendranagar PS Pradhan nagar Dist Darjeeling. ii) Ram Parvesh Ram (43) S/O Lt Punindar Ram of Cooliepara Rajendranagar PS Pradhannagar Dist Darjeeling iii) Sanjay Singh @ Potol (22) S/O Lt Dinesh Singh of Gurung Busty lohar Patty PS Pradhannagar Dist Darjeeling along with the following articles under proper seizure as per seizure list;

- 1) One nylon hand bag yellow, purple and blue mixed colour which contains 30 (thirty) bottles of Chlorphenirane maleate & Codeine Phosphate Cough Syrup linctus Phensedyl having Batch no PHC22048 manufacture dated June 2022 and expiry date November 2023 and each bottle containing 100 ml and MRP Rs 205.30/- each marked as exhibit A.
- 2) One Silver Colour Motorcycle Royal Enfield bullet bearing registration no WB 72T 6514.

I, SI Youel lepcha (28), S/O- Jai Tshering lepcha of Pradhan nagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted following accused persons namely i) Sunil Mahato @ Bholu (35) S/O Lt Sujjan Mahato (of Cooliepara Rajendranagar PS Pradhan nagar Dist Darjeeling. ii) Ram Parvesh Ram (43) S/O Lt Punindar Ram of Cooliepara Rajendranagar PS Pradhannagar Dist Darjeeling iii) Sanjay Singh @ Potol (22) S/O Lt Dinesh Singh of Gurung Busty lohar Patty PS Pradhannagar Dist Darjeeling to the effect that on 31.08.2023 at about 16.30hrs I received a specific source input that three persons are possessing huge quantity of drug based syrup at Siliguri Junction near Army Camp under PS Pradhan nagar Dist Darjeeling to sell the same to their designed local customers.

The matter was diarized in Pradhannagar PS GDE No. 1752/23 Dated 31/08/2023 and subsequently, I informed the matter to the inspector In charge, of Pradhan nagar Police Station in written and being directed, I along with SI Abhishek Theeng, ASI Manoj Kr Roy, ASI Biplab Das, CV 242 Rakeh manger, CV 223 Swapan Chettri, CV 128 Ajay Kumar Sahani of Pradhan nagar PS, SPC along with investigation kit left for Siliguri Junction near Army Camp under PS Pradhan nagar Dist Darjeeling by Govt. vehicle bearing no WB74AC9851 to verify the veracity of the information. This refers to Pradhan nagar PS GDE No. 1753/23 Dt. 31.08.2023 and M.C.C No-2164/23 Date- 31/08/2023

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to Siliguri Junction near Army Camp under Pradhannagar PS I contacted two persons namely 1) Rana @ Guddu Saha (21) S/O Raja Saha of South Ambedkar Colony w/n01 PS Pradhannagar Dist Darjeeling. 2) Anuj Mondal (23) S/O Pramod Mondal of Sisudangi opposite of BSNL tower PS Matigara Dist Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Siliguri Junction near Army Camp under Pradhan nagar PS at 17.15hrs and Subsequently, being pointed by my source detained above noted 03 (three) persons were dealing at the spot near parked motor cycle bearing registration no WB 72 T 6514 style as Royal Enfield silver in colour after seeing the police party they tried to escape from the spot, somehow we apprehended them.

Thereafter, we disclosed our identity and the information in hand and stated them as well as the bag under their possession will be searched for the purpose and I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions. Consequently, I informed the matter to I/C Pradhan nagar PS and as per his kind order, I informed to Shri Santanu Tarafder, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused persons suspected to be possessed syrup based drugs illegally and requested him to come at the spot to remain present and to supervise the search and seizure.

Accordingly at 18.30 hrs Shri Santanu Tarafder, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot and in presence of two independent witnesses I searched the detained persons following all formalities, keeping their decency and recovered the above noted articles from their joint, exclusive and conscious possession of the accused persons namely 1) Sunil Mahato @ Bholu (35) S/O Lt Sujjan Mahato of Cooliepara Rajendranagar PS Pradhan nagar Dist Darjeeling. ii) Ram Parvesh Ram (43) S/O Lt Punindar Ram of Cooliepara Rajendranagar PS Pradhannagar Dist Darjeeling iii) Sanjay Singh @ Potol (22) S/O Lt Dinesh Singh of Gurung Busty lohar Patty PS Pradhannagar Dist Darjeeling.

It has been found from the nylon hand bag under the following accused persons 1) Sunil Mahato @ Bhola ii) Ram Parvesh Ram iii) Sanjay Singh @ Potol containing 30 (thirty) bottles of Chlorphenirane maleate & Codeine Phosphate Cough Syrup linctus Phensedyl having Batch no PHC22048 manufacture dated June 2022 and expiry date November 2023 and MRP Rs 205.30/- each.

Further, on demand in presence of Shri Santanu Tarafder, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC. The detained persons namely 1) Sunil Mahato @ Bhola ii) Ram Parvesh Ram iii) Sanjay Singh @ Potol failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I recovered One nylon hand bag yellow, purple and blue mixed colour which contains 30 (thirty) bottles of Chlorphenirane maleate & Codeine Phosphate Cough Syrup linctus Phensedyl having Batch no PHC22048 manufacture dated June 2022 and expiry date November 2023 and MRP Rs 205.30/- each. One Silver Colour Motorcycle Royal Enfield bullet bearing registration no WB 72T 6514 and seized the same from the joint, exclusive and conscious possession of above noted accused persons namely i) Sunil Mahato @ Bhola (35) S/O Lt Sujjan Mahato of Cooliepara Rajendranagar PS Pradhan nagar Dist Darjeeling ii) Ram Parvesh Ram (43) S/O Lt Punindar Ram of Cooliepara Rajendranagar PS Pradhannagar Dist Darjeeling iii) Sanjay Singh @ Potol (22) S/O Lt Dinesh Singh of Gurung Busty lohar Patty PS Pradhannagar Dist Darjeeling under proper seizure list in presence of independent witnesses and Shri Santanu Tarafder obtaining their signature and being acknowledged by the accused persons under proper videograph.

Subsequently, I labelled and sealed the seized articles in presence of Shri Santanu Tarafder, Assistant Commissioner of Police Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused persons. The whole process of seizure was made in between 18:30hrs to 19:25 hrs.

Being further asked, the apprehend persons namely 1) Sunil Mahato @ Bhola ii) Ram Parvesh Ram iii) Sanjay Singh @ Potol admitted in presence of Shri Santanu Tarafder and other independent witnesses they admitted their guilt and stated that they are purchasing the narcotics substance from various sources that they procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed local customers for their personal gain by illegal means and also disclosed that they have been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally since long for their wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely 1) Sunil Mahato @ Bhola ii) Ram Parvesh Ram iii) Sanjay Singh @ Potol directly involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Therefore, I arrested the above noted accused persons namely 1) Sunil Mahato @ Bhola ii) Ram Parvesh Ram iii) Sanjay Singh @ Potol after observing all formalities and informing the ground of arrest and issued necessary Memo of Arrest and the family member of the arrested persons will be informed as earliest.

Under the above circumstances, I am praying to you that a specific case under proper section of law may kindly be started against following accused persons namely i) Sunil Mahato @ Bhola (35) S/O Lt Sujjan Mahato of Cooliepara Rajendranagar PS Pradhan nagar Dist Darjeeling ii) Ram Parvesh Ram (43) S/O Lt Punindar Ram of Cooliepara Rajendranagar PS Pradhannagar Dist Darjeeling iii) Sanjay Singh @ Potol (22) S/O Lt Dinesh Singh of Gurung Busty lohar Patty PS Pradhannagar Dist Darjeeling and arrange for its investigation.
