With due respect, I Smt. Debi Saha, D/o Late. Ranjit Kr. Saha, W/o Sri Barun Majumdar at present resident of Rabindra Nagar, near Rabindra Sangha Club, P.O. & P.S.- Siliguri, Dist.-Darjeeling, Pin-734006, beg to inform you that I got married with Sri. Barun Majumdar, S/o Lt. H.B. Majumdar, R/o- Khaprail Bazar, P O.- New Chumtal Dist.- Darjeeling, Pin-734009, on 03.02.2020 according to Hindu rites and customs and at the time of marriage several valuable articles like gold ornaments including- choker necklace, 2 balas. 2 churs, nath, tikli, pair of earrings, also chain, finger ring and bracelet for groom were given, all together measuring approximately 460 grams were given. Apart from gold, bed, alna, godrej, 5 seated sofa set, 4 chait dining table, dressing table, 42 inches LED T.V., fridge has been given as per demand by my husband and mother-in-law namely Ganga Majumdar.

That after marriage I used to reside in my in law's house for 4-5 months, but after that my husband and mother-in-law started to create pressure upon me for money of Rs. 10 lakhs from my father's house as the same was very much required by them for the purpose of renovation of their residential house.

It is pertinent to mention here that, my father was ill and paralysed since long before my marriage (and he expired on 27.06.2022) and my maternal uncle somehow managed to give my marriage by investing all of his earnings and when I expressed my inability for payment of such big amount then my husband started to create physical and mental torture upon me with the direct instigation of my mother-in-law, as a result of which I was admitted in NJP Railway Hospital and was then referred to Anandaloke Hospital in the month of August 2020.

It is painful to mention here that my husband as well a mother-in-law, both are habitual drunkard and after consuming alcohol both of them used to torture me physically at their own wishes and I being a helpless woman used to swallow all such torture with a hope that everything will be alright in the future.

It is to be noted here that after I gave birth to a male child on 29.06.2022 namely, Kaustav Majumdar, my husband never ever came to me or performed his duty as an ideal father and husband and when I tried to contact him over phone in all such occasions he used to behave roughly with me and used to state that he will take back my minor baby and then go for second marriage.

That it is painful to mention here that all of my valuable articles are still lying and kept by my husband and mother-in-law and all of my gold ornaments also lying in the State Bank of India,

It is to be noted here that my husband is a Central Govt. employee (Railway Department) and presently posted at Siliguri Junction and there also my husband used to threatened my relatives when they had been to his office for talking about me and my minor son.

In the above painful circumstances, it is therefore prayed that you will be kind enough to enquire into the matter immediately and further be pleased to take appropriate legal steps against my husband, father-in-law and mother-in-law as stated above in order to give justice to a helpless woman.
