Sub: - Written complaint against 01(one) TOTO Driver plying illegally at Flyover approach, Venus More without any valid documents causing obstruction to public way.

Sir,

I ASI Manotosh Barman of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 30.08.23 around 12.25 hrs, while on duty at Venus More found one (1) TOTO without any registration number stationed at Flyover approach, Venus More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Kanak Singh (23 yrs) (Mobile No.9832697114) S/O Krishna Singh of Ambika Nagar, PS-NJP, Dist-Jalpaiguri. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after following all rules and formalities.

Therefore I would request you to kindly start a specific case against the above noted person (TOTO Driver) under proper section of law from your end.
