Sir,

With due respect, I, SI Biswajit Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against accused namely; (1) Haripada Das @ Ganesh (65 yrs/M) S/O -Lt. Satish Das of Khudiram Colony, Bagrakote, Ward No. 18, PS Siliguri, Dist. Darjeeling after producing him under arrest along with following articles;

1). 11 (Eleven) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ML Rs. 155/- each total 6.600 Ltrs. (Valued total Rs 1705/-), under proper seizure list, labeling and memo of arrest.

In this regard I beg to report that on 30.08.23 at 17:30 hrs myself along with ASI Subir Sen, ASI Debasish Das CV/622 Ramanath Barman and CV/283 Prasenjit Dey left for conducting raid against illicit liquor vide Siliguri PS GDE No. 1493 Dtd. 30.08.23. While conducting special raid against Illicit liquor at khudiram Colony, Bagrakote under Siliguri PS received specific source information that one person had stored and selling huge quantity of illicit Liquor at his house located at khudiram Colony, Bagrakote under Siliguri PS without any valid documents. I shared the information with I. C. PS and as per his direction without making any unnecessary delay as shown by the secret source, at 17:45 hrs I along with Force conducted raid khudiram Colony, Bagrakote under Siliguri PS and on being shown and identified by the source apprehended one person with above noted seized bottles of illicit liquor and on interrogation he admitted that he had been selling the above noted seized articles to the customers in concealed manner at his locality. In presence of witnesses, I demanded him to produce the documents or license, cash memo of the said liquor but he failed to produce any documents in support of above noted illicit liquor and selling the same to customers for his wrongful gain. On interrogation, he disclosed his name and identity as Haripada Das @ Ganesh (65 yrs/M) S/O -Lt. Satish Das of Khudiram Colony, Bagrakote, Ward No. 18, PS Siliguri, Dist. Darjeeling. I, accordingly seized those illicit liquors in between 18:05 hrs to 18.35 hrs in presence of independence witnesses namely (i) Sanjay Das (32) S/O - Lt. Sambhu Das of Bagrakote Sraban Nagar near Uttar Banga Office, P.S-Siliguri Dist, Darjeeling (ii) Pawan Ram (19) S/O- Lt. Raju Ram of Khudiram Colony, Bagrakote, Ward No. 18, PS Siliguri, Dist. Darjeeling after preparing proper seizure list duly signed by the witnesses and accused, also labeled the same. Then, I arrested him U/S 41 CrPC after informing his ground of arrest.

As the above noted seized articles are to be suspected be of Illicit Origin and selling the same illegally. I, therefore, pray before you to take legal action against him under proper section of law.
