In producing herewith 01(One) arrested person namely Bibek Ghosh, \$/O-Lt. Bishnu of Vill-Jyotinagar colony W/No-04, PO+P8- Biliguri, Dist- Darjeeting (Paddler of Toto (E-rickshaw), without number plate, Red Colour) along with his Toto under seizer, I SI Ranjit Roy of Jalpalmore Traffic Guard, Biliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 30.08 2023 at about 18:25 hrs I along with ASI Dhiraj Chhetri, C-203 Dipen Barman and CV-554 Budhu Barman while performing traffic regulation duty at AH-2, Jalpaimore, PS-Siliguri, Dist- Darjeeling found that, the above noted person was plying his Toto (E-rickshaw), as noted above on AH-2 by violating Govt.
