Sir,

In producing herewith one (01) accused person namely Raj Kumar Mandal (M/25), S/O- Mantu Mandal of Khalpara, Vivekananda Road, W/No - 07, PS. Siliguri, Dist- Darjeeling along with seized articles viz. 10(ten) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 06 liters, value Rs 1550/- I, SI-Basudeb Guha presently posted at Siliguri Police Station, SPC would like to lodged this written complaint against the above noted person to the effect that today (31.08.2023) at 16.45 hrs while performing Special raid duty, myself along with ASI Debasish Das, ASI-Subir Sen, CV/622 Ramanath Barman and CV/ 283 Prasanjit Dey had been to Tikia Para Sabji Market and received secret source information that the above noted person has stored liquor at his Shop. Then I cordoned the Shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the Shop. On being search of his Shop in presence of available witnesses the above noted seized article is found inside his Shop. On being asked he failed to produce any valid license/papers for storing of such article. Then I seized the above mentioned article under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 17.05 hrs to 17.35 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely Raj Kumar Mandal (M/25), S/O- Mantu Mandal of Khalpara, Vivekananda Road, W/No - 07, PS. Siliguri, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
