Sir,

In producing herewith one arrested accused person namely Sankar Dey (Male/62) S/O-Lt Banku Bihari Dey of Rabindra Nagar, near Rabindra Sangha Club, Ward No 21, PS- Siliguri Dist- Darjeeling along with seized articles (i) 12 (Twelve) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01.

I, ASI Kalachand Singha of Khalpara TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 31/08/2023 at 20:05 hrs during evening mobile Van duty I received secret source information that, one person is carrying huge quantity of country spirit towards M N Sarkar road, near Shovraj Hotel PS- Siliguri Dist- Darjeeling under Khalpara TOP. Accordingly I informed the information to OC Khalpara TOP and as per his direction I along with C/678 Dipak Mandal, C/ 284 Shankar Singha, left for PO to work out the information. On arrival at M N Sarkar road, near Shovraj Hotel at 20:20 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Rabindra Nagar and adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 12 (Twelve) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 12 (Twelve) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 155/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- 01. Under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 20:35 hrs to 20:55 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1550/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Sankar Dey (Male/62) S/O-Lt Banku Bihari Dey of Rabindra Nagar, near Rabindra Sangha Club, Ward No 21, PS- Siliguri Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
