I, Miss Pavitra Sharma, Daughter of Sri Mahesh Sharma, resident of Milan More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling beg to report that on 28.08.2023 at about 10.30 a.m. near Mega Basket Mall, Champasari, when I was on the way for my Hotel Management class at Shine Institute, nearby of said Mega Basket Mall, one Sri Sapan Roy, father's name not known, resident of Shanti Colony, Raigunj, suddenly appeared before me and held my both of wrists tightly and forced me to go with him. He told me not to shout or else he would kill me by knives on the spot. He was also threatening me saying that "if you don't marry me then I shall kidnap you from any place and shall arrange my friends to rape you in group". Due to his such sudden attack, I got heavily feared. I wanted to shout for help but I don't know as to why my tongue was suddenly stopped to work. Unfortunately, the place was also empty then. Nevertheless, I tried my best to get free and managed to escape from his clutch. I ran from the spot. In a distance some men were coming. So, he did not follow me. After a while when I reached at a safe place I informed my parent over mobile phone. Later, my parent came and took me to home and since the date of such incident I went under depression. The incidental scene and the dangerous face of said Sri Sapan Roy was roaming again and again in my brain. I could not speak easily and as such I could not report you in time.

That sir, said Sri Sapan Roy is very desperate and dangerous man. A few years back he was working as a helper in Utpal chicken shop a Milan More which is near my residence.

That sir, I am 19 years old girl and have to travel several places for learning purpose and if any action is not taken against him then he will not hesitate even to kidnap and kill me at any place.

Therefore, I humbly request you to kindly lodge the matter stated above as a complaint against said Sri Sapan Roy and take a prompt legal action against him as per the provision of the law so that I may remain safe.
