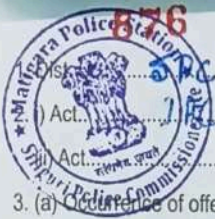

I, Babu Saha, Son of Sri Abhiram Saha, resident of Rajarammohan Ray Road, Hakimpura, Ward No. 15 of Siliguri Municipal, Post office & Police station Siliguri, District Darjeeling, would like to state I have lodged the above referred case against said Shetal Das and thereafter he complied the notice under Section 41A of Cr. P.C. and took bail from the Ld. Court. That after taking bail said Shetal Das had not handed over the key of my building even after my request and instruction of the investigation officer of the above referred case. That thereafter getting bail he again visited my building along with Kartick Biswas (Plumber) break the lock and entered into the building and demolished the wall structure of my said building. He along with Kartick Biswas completely damaged the plumbing works and filled the same with cement also damaged entire electric wiring of the building and they took away the plumbing articles, electrical wire and switches lying there. That thereafter he call me into my phone number 9851760505 from his phone number 6296190275 on 06.08.2023 at about 5 PM and at that point of time I was talking with officer-in-charge, Uttarayan Outpost under Matigara Police Station and threatened me with dire consequences.

That due to such illegal acts and activities of said Shefal Das and
Kartick Biswas I am in shocked and feat as well thinking that how the
criminal like him got bail from court, they are very dangerous in
nature they do not have fear of Police and judicial system.

Under the above circumstance I hereby lodging this complainant
against Shefal Das and Kartick Biswas for their illegal acts and
activities and would request you to investigate the matter the
habitual wrongdoer can be punished as per the procedure established
by Law.
