Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri.

Respected Sir,

I, **Smt. Rimpa Lohar (Dey)**, wife of Sri Sudhan Lohar, residing at my matrimonial home/shared household i.e. at Prakash Nagar, Limbu Busty, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my father-in-law, Ranjit Lohar, mother-in-law, Smt. Lalita Lohar, brother-in-law, Bablu Lohar, Dipu Lohar, both are son of Ranjit Lohar, Sister-in-law, Rina Lohar (Pradhan), Wife of Kalu Pradhan, Shila Lohar and her husband Bijla Lohar, all are residing at Prakash Nagar, Limbu Busty, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that as follows:-

- (1) That I have been living with my husband and two children at my matrimonial home which is a shared household along with my in-laws since my marriage in the year, 1997 with my husband said Sudhan Lohar but since last 13 years without rhymes and reasons, my father-in-law and mother-in-law on the instigation and incitement of other-in-laws and my husband's relatives above-named at the regular interval of time have been committing mental torture upon me by abusing in most derogatory and filthy languages and have been threatening me and my children to drove out of my matrimonial home but I tolerated the same all these days with a hope that one day their commission of mental torture upon me would be stopped but all went in vain.
- (2) That on 31-08-2023 at about 11:45 pm, my father-in-law and my mother-in-law on the abetment, intigation and incitement of other-in-law and relatives of my husband above-named abuse me in filthy and derogatory languages and physically assaulted me and thereafter pour kerosene oil on my person and tried to ablaze me with an intention to kill me but somehow my husband, my Jaa, Dipti Lohar, and Christina Lohar came rushing and rescued me from their clutches and thereafter my husband and my son immediately took me to Siliguri District Hospital for my treatment.

So, therefore, I humbly request your goodself to take legal action against the above-named persons and booked them under the provision of law at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
