Sir,

I, Athilesa Ghosh, daughter of late Manoj Ghosh, residing at 88/1 Rashbehari Sarani, Khelaghata more, Hatikompani, Siliguri - 734001, Dist. Darjeeling, had received a call from FedEx on 01-09-2023 where I was told that a parcel was being sent in my name to Taiwan from Mumbai and the parcel had got blocked due to some illegal drugs. After that I was told to connect to Mumbai cyber department through telegram (ID - @mumbai cyber dept).

After going on call on telegram @mumbai cyber dept, some police IDs were sent to me on telegram message and I was told to transfer amounts from my ICICI Bank Account (A/C No - 007201520392) so that RBI could verify my account. I trusted them and they said that the amount that will be deducted will be returned within minutes, after verification from RBI. There were 3 transactions that I did from my ICICI A/c of Rs 5,00,016.70, Rs 1,67,317.70 and Rs 1,95,017.70 (total - Rs 8,62,352.10) through IMPS transaction.

Please help me resolve the issue and help me get the deducted amount back.
