

I Kuber Sharma, S/o Gouri Shankar Sharma permanent resident of Rajasthan Guest House, Vivekananda Road, Siliguri and present resident of F0709, Uttorayon Township, Matigara. On dt. 02/09/2023 at around 04.30 P.M. I was at Chath Ghat, Uttorayon where I was manhandled by a local goon by the name of Tapan Das, resident of Uttorayon Ph. 9434046820 and 1 other who asked me to leave the area and wherein after confrontation he grabbed me by the collar and physically assaulted me with a gun to my stomach. The two of them also raised verbal abuses and also threatened to come after my family if I complain, they thereafter fled the scene.

I request you to please help for the safety of my family and my life and register an immediate FIR against the above mentioned.
