Subject: Written Complaint

Respected Sir,

I. Smt Ranjita Roy, Wife of Sri Sumit Naskar. Daughter of Ranjit Roy. resident of Pratima Banarjee Sarani. Pipe Line. Desbandhu Para. Post Office – Siliguri Bazar, Police Station- Siliguri, District- Darjeeling, Pin Code- 734005, would like to inform you as follows:-

1. That I was married to Sumit Naskar, Son of Subhas Naskar, resident of H/O Sri Dulal Ghosh, Narmada Bagan, Gali No. 2, P.O. Champasari, P.S. Pradhan Nagar, District Darjeeling, Pin: 734003 out of love affairs and said married was registered on 08.07.2016.
2. That everything was going well in our marital life till November 2022.
3. That since December 2022 there is a drastic change in the behaviour of my husband. He became a regular drunker and he used to come at my matrimonial house hardly one to two days in a week and whenever I asked him the reason, he used to say he was busy in conducting tour for the tourist as he is a cab driver of his own car.

It is right place to mention here that whenever my husband came to my matrimonial house he used to stay in a separate room and whenever I asked him for the planning of our baby he used to avoid the same.

4. That the above noted act of my husband is continued and in March 2023 when he came to matrimonial house. I again asked him the reason for his act and behaviour to as me and hearing this my husband became furious and started assaulting me and told that he was in a extra material affair with one Madhabi Sarkar, wife of Ripon Sarkar, having her shop under name and style "GALAXY", a massage parlour at the basement at City Center, P.S. Matigara, District Darjeeling, Pin: 734010 who is already married and mother of two children and at

that time my mother-in-law Urmila Sarkar, wife of Subhas Naskar and my Father-in-law Subhas Naskar, son of Late Adaita Naskar was present and they have instigated my husband's illegal act

It is to be mentioned here that at that time my husband also told that he married said Madhabi Sarkar and staying in a rented house some where in Matigara area.

5. That since then my husband, my Mother-in-law, my Father-in-law, on the instigation of my brother-in-law namely Sujit Naskar, Son of Subhas Naskar and my Sister-in-law namely Debika Naskar, wife of David Lakra, both are residents of Madhyamgram, P.O & P.S. Madhyamgram, District North 24 Paragans, Pin: 700129 used to torture me both physically and mentally on a regular basis and day by day the rate of torture increased.
6. That on 13.08.2023 my husband came to my matrimonial house and told me that said Madhabi Sarkar is engaged with the business of immoral trafficking of women and my husband is also a partner of her and he forced me to involved in the said illegal business and also told me that I have to attain their clients time to time
7. That after that I protested against his illegal act and on my protest my husband along with my Mother-in-law and Father-in-law started assaulting me and forcefully ousted me from my matrimonial house and since then I am residing at my grandmother's house in the above noted address.
8. That after that I tried to contact with my husband and my in laws but they avoided my call each and every time. Finding no other alternative yesterday I went to my matrimonial house and reaching there my husband along with my Mother-in-law, and Father-in-law started abusing me in filthy languages and again ousted me forcefully by assaulting me.

It is pertinent to mention that in every above noted act of my husband, my Mother-in-law and Father-in-law said Sujit Naskar and Debika Naskar used to instigate them over phone and in conspiracy with Madhabi Sarkar also planned to sell me out to any third person but they failed to do so.

It is therefore requested to take immediate and appropriate legal action against Sumit Naskar (9635150970 & 8346949598), Subhas Naskar, Urmila Naskar (9547257923), Sujit Naskar (7980341884), Debika Naskar (7449355761), Madhabi Sarkar (9832169940 & 9800210999) for their above noted illegal acts for torturing me both physically and mentally and tried to involve me and sell me out immoral trafficking business by making out criminal conspiracy.
