Dear Sir,

I, Ms. Anisha Sharma, wife of Shri Narendra Sharma, Principal, Delhi Public School, Siliguri, having office at Delhi Public School, Dagapur, Post office and Police Station- Pradhan Nagar, District- Darjeeling, would like to inform you that today we have noticed from our CCTV footage that on 29.08.2023 at about 12.30 a.m. one unscrupulous person illegally entered into our school premises and it was also noticed that he committed theft of some copper wire of the solar panel which is duly installed in the terrace of our school building. It is relevant to mention here that the said copper wire which was stolen from our school is approximately cost of Rs.2,50,000/- only. It is our reasonable apprehension that if such illegal activities are not stopped this may turn into a big incident someday.

I, therefore, request your goodself to look into and investigate the matter and book the culprit in accordance with appropriate provision of criminal law.
