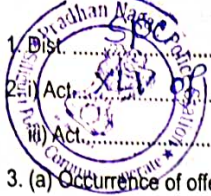

Sir,

I Subhash Chettri resident of Purbachal Pradhan Nagar, P.O. & P.S. Pradhan Nagar, District Darjeeling would like to lodge this complaint against Pooja Rani Gupta Daughter of Gobind Sen Gupta. Resident of Hemtabad, Near Adarsha Vidhalaya, District North Dinajpur to the effect that my son Kamal Chettri (Now deceased) got married with Pooja Rani Gupta on 28<sup>th</sup> January 2022 and started living together as husband and wife at my aforesaid residence at Purbachal Pradhan Nagar, P.O. & P.S. Pradhan Nagar and they have stayed together peacefully and happily for more or less one year but after some days, said Pooja Rani Gupta and her family members have started pressurizing my son to bring money to meet their day to day problems. My son was so innocent that he has loved his wife so much as such he has fulfilled all the desire of said Pooja Rani Gupta but her ill motive is to grab money from my son without saying any thing to my son, she left our house on 24<sup>th</sup> February 2023. After she left her matrimonial house, my son has several times requested her to come back home and she used to ask her to send money so that she could come but even after sending money she didn't come, finding no alternative, my son went to the house of said Pooja Rani Gupta where said Pooja Rani Gupta and her family members, Gobind Sen Gupta, Mamta Gupta and Kaushik Sengupta have forcefully asked my son to bring Rs.8,00,000 (Rupees Eight Lac) only for constructing their house and after returning from their house, my son (now deceased) has managed to arrange a sum of Rs.5,00,000 (Rupees Five Lac) only for the sake of saving his matrimonial life but said Pooja Rani Gupta and her family flatly refused to take that money and pressurized my son to bring the entire amount of Rs.8,00,000 (Rupees Eight Lac) only for constructing their house. Now my son has become frustrated and he started becoming depressed, keeping himself away from the society.

On the night of 31.08.2023 at about 9 P.M said Pooja Rani Gupta asked my son to come at Roy Medical Hall, Baghajatin Colony and after hearing this call he was so excited and happy but when he went to meet his wife at Baghajatin Colony, he was mercilessly beaten by the goons hired by said Pooja Rani Gupta and his family. Prior to this my son might have thought that he could manage the amount asked by Pooja Rani Gupta and her family but when he was beaten mercilessly by his own beloved wife, he has lost all the hope to live his life and seeing no alternative, 01.09.2023, he has committed suicide by hanging at his own room and it is not a simple suicide but a well planned murder by Pooja and her family.

From the above facts, acts and conducts, it is crystal clear that said Pooja Rani Gupta has married my son just for the sake of squeezing money and she has no love, care and affection towards my son and said Pooja Rani Gupta and her family are fully liable and responsible for the cause of death of my son, his last suicide note and several other notes in his facebook page speaks itself.

I, therefore humbly request you to take stern and drastic action against the said Pooja Rani Gupta, Gobind Sen Gupta, Mamta Gupta and Kaushik Sengupta in accordance with law.
